Annual Membership Meeting Buena Vista Hotel, Orlando, Florida Tuesday, August 30, 2011

The meeting was called to order by President Joan Bradshaw at 10:30 AM. Chaplin Tracy Tesdall provided a thought for the day.

A pad of paper was circulated for members and guests to sign in order that attendance could be recorded.

Our Worthy Chief (President Bradshaw) recognized special guests, Life members and other retirees that were in attendance.

A summary of 2010-2011 year was provided by President Bradshaw: "With a focus on the future, efforts were made to enhance our profile through increased outreach and improved communication at the state and national level. The Alpha Delta Chapter of ESP was represented nationally at JCEP in San Antonio, at the National ESP Conference in Jackson Hole, Wyoming, and the PILD) Conference in Alexandria, Virginia. Organizational communications was also an important goal for this year, as new and improved website was developed and maintained. Applications for awards, recognition and scholarships were solicited by new Member Services Chair Adrian Hunsberger, with many state winners being successful at the Regional and National level. In addition, a report was made by the 2010 Hackler/Cook-Scholarship Recipient Judy Corbus, who used the funds to attend the 2010 NEAFCS Annual Session in Portland, ME, where she accepted the Southern Region and National Extension Housing Outreach Award for her homebuyer education program. Additional highlights of their professional improvement program were included in the ESP Exhibit in the EPAF Trade show.

Mary Keith, a member of the ESP National Awards Committee made a presentation of the ESP Angus Scholarship for Professional Improvement to Terry DelValle, Duval County.

Life Member Committee Chair Mary Chernesky presented 25-year service award certificates to: John Lilly, Jefferson Co., William L. Sheftall, Jr., Leon Co., Betty M. Miller, Leon Co., and Celia Hill, Lee Co. She also noted that the Chapter Retiree Service Award was to be presented to Michael McKinney, Hillsborough County later at the Conference.

Minutes of the August 31, 2010 Annual meeting were presented by last year's secretary, Dr. Ray Mobley. A motion was made and seconded to approve the minutes as presented. All were in favor.

Treasurer Lori Wiggins reported that income for 10/1/10 - 9/30/11 was \$8,536.53 and expenses for the same period were \$8,888.90; the difference of \$352.37 was covered by funds carried forward. A motion was made and seconded to approve the treasurer's report. All were in favor.

President Joan Bradshaw reminded the ESP members of their responsibilities through the rest of the week at EPAF.

Committee Reports

Tim Wilson, Professional Development Chair reported that the Abstract Committee reviewed 20 abstracts that were submitted for our session at this year's EPAF meetings. Of these, 13 scored the minimum 40 point average resulting in a 65% acceptance rate. After completing two years as ESP Abstract Chair, Tim Wilson announced he will step down at the conclusion of the Annual Meeting at EPAF.

Dan Culbert reported that the Annual Report was completed and available at this meeting. Large printed copies were made available to Retirees, while small printed copies were provided to Board members. Other members were urged to review the annual report form the posting on-line.

Jane Corless said that she would retrieve the Treasurer's books from Lori Wiggins after EPAF and conduct an annual audit of our Chapter's financial records. She reported that her audit of the books from last year did not produce any issues.

Treasurer Lori Wiggins presented a budget proposal for 10/1/11 - 9/30/12 for income and expenses of \$8,985.00. A motion was made and seconded to approve the budget for 2011-12. All were in favor.

Brent Broaddus, Chair of the Constitution and Bylaws committee reported there had been no action or item's brought before the committee this year.

Global Relations Chair Dan Culbert noted that during the past year, UF and FAMU Extension faculty conducted ten international Extension programs held in more than nine different countries, encompassing Extension work in 4-H Youth, Family & Consumer science, and agriculture. Dan noted that our faculties are involved with AIAEE, and that National ESP is providing a scholarship to one member of a 8-person UF Extension faculty Sustainability Tour of Costa Rica in 2012. The IFAS IPAT committee named Alex Bolques as the winner of the UF/IFAS Award for Excellence in Internationalizing Extension, and he will also receive the ESP chapter award in Internationalizing Extension. The particulars are outlined in the 2010-12 annual report.

Analyst Dan Culbert reported that Membership Recruitment & Retention efforts were somewhat successful in 2010-11, and the chapter will be presented with a *Platinum Award* in Annual membership Achievement from National ESP at the Syracuse ESP Conference. For the year, there were 102 paid Active Members, including 10 New Active members, and dues were received from two new life members. Total Life membership now stands at 123 members. It is noted that ten member's dues were received after the December 31 deadline, making them ineligible for member recognition and scholarships, so a reminder was made to get those dues in before the end of the year.

Chaplin Tracy Tesdall reported that she will use a little different format for the EPAF Memorial Service this year. We will be honoring 11 former Extension staff, including 4 ESP Life members at the Memorial service, and also recognizing three other IFAS staff persons that have passed on since our last EPAF meeting. Details can be seen in the annual report and the archived Memorial presentation, both of which are on-line.

Past President John Lilly presented the Nominating Committee report for officers of the Alpha Delta Chapter for 2011-12: District Directors – 2 year terms

Terry DelValle indicated that she would prefer to step down, as she has been the director for several terms, but would be willing to be re-elected and serve until a suitable replacement is found.

President-elect Robert Halman Public Issues Chair reported that from April 2-6, 2011 he attended the Joint Council of Extension Professionals (JCEP) Public Issues Leadership Development (PILD) Conference in Arlington Va. Before the conference Dr. Millie Ferrier Chauncey held a conference call to discuss major Extension issues that she felt all Extension personnel should discuss with their legislative representatives during our time in Washington DC. Robert received an appointment with Senator Bill Nelson and had another meeting with US Representative Mario Diaz-Balart. He observed that our state's delegates had a good discussion on our potential meetings with area representatives, and reported that several states were utilizing their entire association representatives in single meetings with their state's legislators. They felt that this made for a more unified voice for their university system. It was decided during this discussion that Florida should adopt a similar tactic when visiting the capital next year.

Resource Management Committee Chair Marjorie Moore reported that the Alpha Delta Chapter has a goal of \$12,500 to support ESP's National endowment/development campaign. Our Alpha Delta chapter has raised a total of \$10,828 toward this effort. These contributions put us in *4th place nationally on the total* contributions and \$46.67 per current Annual and Life Members, which ranks 5th among all ESP chapters. She observed that several Alpha Delta Chapter members have benefited from ESP scholarships and leadership development opportunities. As budgets are tightened, it is more imperative than ever for everyone to contribute. She suggested that a 50/50 raffle be conducted during the annual meeting at EPAF to assist in raising money. We need approximately \$1,672 to reach our goal!

Life member Chair Mary Chernesky gave her report on Retirees/Life Members activities: Two issues of the Retiree Newsletter, renamed *Senior Times* were produced and sent to ALL Extension retirees this year. Special thanks go to Linda Cook – editor and Dr. Marjorie Moore and Bay County – for printing and mailing the newsletter. Past newsletter issues are posted on the website. She is still having difficulty getting addresses for retirees before they leave the system, and as result, communications are not getting through.

The ESP Chapter website has undergone a major revision last year. UF/IFAS IT specialist Ligia Ortega did the revision, and the Board passed a resolution of commendation for her fine work. Constitution and By-Laws Committee

A review of the By-Laws and the standing rule shad revealed a couple inconsistencies between these two documents. The following are offered to the membership for address these issues, and are proposed for discussion at the annual meeting.

Note that the procedures for approving changes to the By-Laws and Standing rules are not specified in either document. It is felt that a simple majority of the members present at the annual meeting can approve these changes.

Proposed By-Laws Amendments

ARTICLE III – Membership

Section 4. Termination of membership:

After one year of non-payment of dues, membership in ESP will be terminated. A person can be reinstated by payment of dues. *plus a \$10.00 reinstatement fee. Retirees are exempt from paying the reinstatement fee.*

<u>Rationale for change</u>: This will insure that the language and procedures in our By-laws is consistent with the Standing Rules, and discourage members from having a lapse in membership.

ARTICLE V – Officers, Directors, and Elections

Section 6. Filling Vacancies:

In the event of a vacancy, Board of Directors shall appoint a member to complete the term of office.

If a vacancy occurs in the President's position, the President-Elect will automatically assume the Presidency for the unexpired term and then serve another full term as President. The President-Elect's position would remain vacant until the next annual meeting.

If a Past President vacancy occurs, the previous Past President may assume the position for the unexpired term.

All other officer and director vacancies will be filled by presidential appointment and ratified by the Board of Directors.

<u>Rationale for change</u>: This will insure that the language and procedures in our By-laws is consistent with the Standing Rules, and discourage members from having a lapse in specify procedures in case an officer vacancy occurs.

Proposed changes in Standing Rules and Policies

Membership

Dues: annual dues are delinquent December 31 of each year.

Dues amounts: Renewing members \$60.00, new members \$70.00 (includes initiation fees), life membership (five times annual national dues) \$200.00. A former member can be reinstated by payment of dues plus \$10.00 reinstatement fee. Retirees are exempt from paying the reinstatement fee.

Delegates

President and President Elect will serve as delegate to all National and Regional meetings with the financial support of the chapter.

President and President Elect or their designee will serve as delegate to all National and Regional meetings with the financial support of the chapter.

<u>Rationale for changes</u>: This will insure that the language and procedures in our By-laws is consistent with the Standing Rules, and provide a procedure for the selection of voting delegates to the National ESP meeting in the absence of the President and President-elect.

The Global Relations committee is charged with promoting the Extension profession and professionalism worldwide. The following are known International Extension programs conducted by UF and FAMU Extension faculty during the past year:



- In March, 8 Extension faculty made a professional development tour of Costa Rica in conjunction with EARTH University. The team was lead by Eleanor Foerste, and included Teresa Olczyk, Becky Jordi, Susan Haddock, Kathleen Ruppert, Sheila Dunning, Terry DelValle, and me. Terry received financial support to attend this program from National ESP through an Angus Scholarship. Others received support from FACAA, NACAA and from the Extension Dean's professional Improvement funds. Outreach efforts from this professional improvement program so far have included a poster at the 2012 Small Farms Conference in Kissimmee *Free Fuel for Remote Locations: Construction of a Biodigester.* There will be two presentations made at this year's EPAF conference that will discuss what was learned. This "EARTH team" will be offering an EPAF Auction basket of goodies from Costa Rica.
- The UF/IFAS International Programs Advisory Team (IPAT) acts as a bridge between all IFAS faculty and the University-wide International Programs (IP) office. I will be stepping down as the county extension representative to the IFAS IPAT committee after 4 years, and looking to make suggestions to our new Extension Dean on a suitable replacement
- IPAT sponsors the UF/IFAS Award for Excellence in Internationalizing Extension, presented to a county Extension faculty for their contributions to building an international dimension into the Extension mission. The IPAT committee honored Norma Samuel with 2011 Award for her outstanding Global work. This award also offers a cash reward!
- IPAT held a one-day on-campus workshop to inform IFAS faculty on ways to become more engaged in international work. The program detailed several UF programs being conducted in Haiti as well as other opportunities to become engaged in International Extension activities.
- Last year's Alpha Delta Chapter's ESP International Service Award winner, Alex Bolques, was sent forward for regional consideration. His Global track record was judged to be worthy of Southern Regional recognition, and he will be traveling to the Mobile conference with other Alpha Delta members. Note that this will be the third consecutive year that a member of our chapter has been so recognized by National ESP. Will Norma Samuel be invited to Galaxy IV next year as another regional award winner in the category?
- I also served as a Southern Region representative to the National ESP Global Relations committee for 2010-12, and have been reappointed for 2012-13. The committee will be offering three workshops at the Mobile conference, including the Poster on the MEAS program. The ESP Global Relations Committee will also be continuing to videotape short interviews of faculty who have conducted International Extension Programs. These videos are available on the <u>National ESP website</u> and on <u>You-Tube</u>. The videos may be useful to faculty interested in the ways, means and outcomes of Going Global.
- Norma Samuel and I will be presenting a poster on the Modernizing Extension and Advisory Services (MEAS) grant program at EPAF and at the National ESP conference in Mobile. MEAS is developing materials to assist Extension programs in other countries, and UF is a partner in this consortium.

2012 PILD Conference

The Public Issues Leadership Conference in Arlington Virginia, allowed me and 13 others to network with legislators and provide them with not only University of Florida IFAS Extension based funding issues but also issues locally in Collier County. It was my goal to inform our local legislators of the value of Extension programming to their community and the implications this Tax Reform bill on this long standing community service.

This year I was fortunate to be selected to present at Tuesday breakout session my project presentation - *Poverty: Attaining Action Through Community Circles.*

This year we (the associations present) acted as a team and divided up it groups of 2-3 to travel over to the Hill for our visits with legislators. In our team discussions it was emphasized that we need to become more pre-conference organized: with our message, lining up appointments and materials to bring with us. We found that one major asset for University of Florida that we have not previously utilized is the <u>Florida House</u> which is located very close to House and Senate buildings. This could easily become a venue to house a reception for Florida House and Senate members.

Talking points provided by administration

Program Funding - Public funding for research for agriculture and natural resources continues to decline in the U.S. while other countries are now beginning to invest heavily in research. If this trend is not reversed we could find ourselves at a competitive dis-advantage in the global economy, will not be able to keep up with increasing threat of exotic pests and disease as well as invasive species.

Farm Bill - Since the pathways for public funding for agriculture and natural resources research has and is changing, the next Farm Bill will be even more critical to Florida. Unfortunately, in light of the nations' economic status we are concerned that this Farm Bill could potentially be the least resourceful in history. We need to focus our efforts and enlist the help of our congressional delegation on ensuring that Florida benefits from the next Farm Bill.

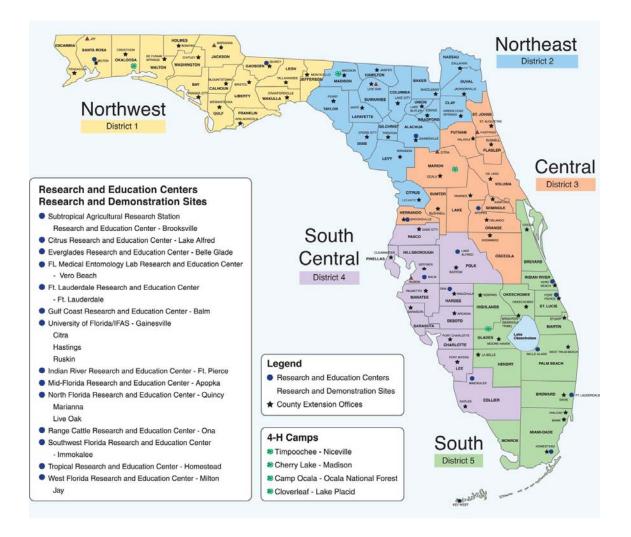

State Budget Update:

The University of Florida was handed another budget cut this year. Although UF/IFAS Research and Extension were held harmless (level funding compared with last year), the UF College of Agricultural and Life Sciences was cut \$1.46 million (4.7%). Research and Extension Administration were asked to share this cut to the tune of 0.335 million. Extension is handling these budget cuts at the operational level such that no faculty positions were lost.

Other Notable items:

- Contact was made with Joy Jordan to join as lifetime member.
- Plan to invite incoming Dean of Extension transfer membership to Alpha Delta Chapter, ESP
- Tim Momol invited state specialists to participate in the upcoming Central District meeting on April 26; positive effort to include state faculty in district functions. More opportunities like this would be welcome.
- Ongoing difficulties connecting with and recruiting state members. Most commonly provided reason is that state specialists already maintain multiple professional association memberships, so do not want to spend money on another. Need suggestions on how to overcome this barrier.
- Fifty-three county faculty have enrolled in the Extension Teaching & Learning Certificate program being offered by AEC. The program is free for IFAS faculty for 2012; registration costs for the future are unknown with the uncertainty of what the incoming Dean will want to fund.
- The Association for International Agricultural and Extension Education (AIAEE) had their annual meeting in Thailand in May. Several IFAS state and county faculty attended and gave presentations. The 2013 meeting will be in Fort Worth, TX, and the tentative location for 2014 is Miami. ESP members are encouraged to share their scholarship through AIAEE. Calls for proposals will go out in the fall.

The meeting was called to Order by our Worthy Chief, Dr. Ray Mobley at 2 PM.

Roll Call: The following members were present: Ray Mobley, Marjorie Moore, Adrian Hunsberger, Dan Culbert, Brent Broaddus, Mary Chernesky, Joan Bradshaw, Tracy Tesdall, Terry DelValle, Marcus Boston, Amy Harder, Kathleen Allen and Mary Keith.

The Draft Agenda for today's meeting was approved. Ray said that he may have to leave early, and was going to ask President-elect Robert Halman to take over at that point.

Board Minutes: August 23, 2011 Mary was not able to access the minutes of the last board meeting, and moved that approval of the 8/23/11 minutes be tabled until the next board meeting. Motion seconded and approved.

Minutes of the General Membership Meeting on August 30, 2011 were taken by Andy Toelle, but have not been submitted. Secretary Dan Culbert will follow-up.

Treasurer's Report: Lori Wiggins was not present, but had reported there was no change in the Treasury since the annual meeting. [Note: report is available in annual report online, page 14. http://epaf.ifas.ufl.edu/esp/pdfs/2010.2011.Annual.pdf]. The books are being audited and an updated report would be available at next board meeting.

Committee Reports

EPAF Report: Joan Bradshaw noted there was no update as the Conference planning committee has not met since the conference.

Member Services /Awards: Adrian Hunsberger noted that her report was included in the annual report <u>on-line, p. 20</u>. Se noted that our chapter can do better as there were several awards not provided for lack of applications, and she also noted that there was no competition for those categories awarded this past year. She asked what the Board can do to assist in this matter. The suggestions were to send personal notes or emails to potential applicants, encouraging them to apply. Tim Wilson had applied for the Mid-Career award, but Adrian said she never received notification that an application was submitted from the National ESP office. They have been notified and feel the situation has been resolved, and Tim indicated he will resubmit his application in the coming year. The late in the year change in Committee Chairmanship was also suggested as a contributing factor. It was also suggested that award applicants print and send a backup copy of their web-based applications directly to the Chair (Adrian Hunsberger) as a backup to the ESP website system. Marjorie Moore suggested that ESP Directors can also help recruit award applications at their respective District faculty meetings.

Deadline for award applications has not yet been set, but it will probably be in mid June for chapter awards. Regional awards applications need to be forwarded to National by March 1, 2012.

Global Relations: Dan Culbert reported that he will be making a presentation on UF/IFAS International Extension programs at the National ESP conference in Syracuse. There have been several Extension programs held in Costa Rica with EARTH University which will be summarized in this conference concurrent session. He will also be receiving the International Service Award for the Southern Region, the only such award to be presented this year. Eleanor Foerste is coordinating a spring study tour to Costa Rica; there is still room available if there are faculty interested in going. The UF/IFAS International Programs Advisory Team will be holding a Spring IPAT workshop on International programs; the date will be announced soon. If there are other International activities that Extension staff are involved in, faculty are urged to let Dan Culbert know about the particulars.

Membership Recruitment & Retention: Tracy Tesdall has just begun to receive membership renewals; to date there are only 29 renewals and new members. It's still early in the budget year, so many counties have not yet been approached by faculty who use local funds to pay for their memberships. It is imperative that District directors do whatever is appropriate to enlist renewals and solicit new members. Terry DelValle observed that there is a need to focus on new members; those that are newly eligible for membership need to be personally invited to join the fraternity. Mary Chernesky also reminded the board that there is also potential for newly retired faculty to become Life members. In all cases, membership invoices need to be sent to the Analyst [Tracy Tesdall].

Retirees/Life Members: Mary Chernesky reported there is nothing new to report since EPAF. Active members that have had a lapse in membership can join as Life members. She has requested that a new Life member be asked to be the Retiree committee chair. She heard that recent retiree Ray Zerba may be willing to take on this role. Betty Miller (Leon County) will be retiring soon so was asked by Will Sheftall, but she declined. Mary will send information on the role of the committee chair to Terry DelValle, who will ask Ray Zerba.

EPAF Memorial Service: Will Sheftall congratulated Tracy on the format used for the Memorial service at EPAF, and with the consent of the board, will use that forma for next year at EPAF.

Senior Times Newsletter: Linda Cook is compiling the next newsletter. Public Issues: Robert Halman was not on line to give a report. Nominating: Joan Bradshaw has no report at this time. Annual Report: Dan Culbert will be making a few changes to the Annual report that is on-line.

Constitution and Bylaws: Brent Broaddus will be asked to look at the membership lapse provision for Life members.

Professional Improvement/Abstracts: Katherine Allen will be sending out the call for abstracts early. She will also be looking at other ways to encourage Professional improvement opportunities for the fraternity.

Website: Dan Culbert mentioned that recent problems with the National ESP website have been fixed and the site should have full functionality. He said he is willing to give up the role of being the Chapter's webmaster if another member is interested. Marjorie Moore will ask Scott Jackson if he would be interested.

Resource Management (Foundation): Marjorie Moore reported that \$510 was raised at EPAF for ESP. Lori Wiggins will be asked to send these funds to ESP National as soon as she gets the books back. This means that we are only \$1162 shy of meeting the Alpha Delta goal of the \$12,000 pledge to the ESP National Endowment campaign. Mary Keith mentioned that these funds come back to the chapter in the form of reimbursements to persons attending the National ESP conference.

Old Business

EPAF Annual Conference - National ESP Conference will be held in Syracuse NY, October 9-13. Terry Delvalle moved and Marcus Boston seconded a motion that Mary Keith & Dan Culbert be designated as Alpha delta chapter delegates to the 2011 National Conference. Members were asked to review several proposed National By-Law changes posted on line at:

http://conferences.espnational.com/index.php?option=com_content&view=article&id=42&Itemid=26. The board was in favor of supporting these changes in the ESP By-Laws.

New Business

PILD – no discussion JCEP – it was noted that traditionally the President-elect attends this program. *[At this point the Polycom connect failed for several minutes.]*

District Director Reports

NW District: Marcus Boston – no report

NE District: Terry DelValle mentioned her desire to step down as District director. She has approached Mike Davis, Baker County CED, who is willing to take on this role as soon as he is able to submit an application for new membership.

Central District: Mary Sue Kennington- no report

South Central District: David Shibles - no report

South District: Gene McAvoy - no report

State: Dr. Amy Harder expressed a need to articulate benefits of membership that would be of interest to state Extension specialists. This needs to be part of any successful efforts to improve membership among state specialists in ESP.

The Next board meeting will be scheduled for November or December. A motion to adjourn was made by Terry DelValle and seconded by Marjorie Moore. All were in favor.

Alpha Delta Chapter - Epsilon Sigma Phi Board Meeting

December 8, 2011, 11 am - 12 noon, via Polycom

The Winter ESP Board meeting was called to order by Dr. Ray Mobley at 11 am. He noted that Robert Halman's family was going through some health challenges, and asked for a moment of silent prayer in support of our President-elect.

Roll Call - The following members were present Ray Mobley, Lori Wiggins, Dan Culbert, Tracy Tesdall, Will Sheftall, Marcus Boston, Mary Sue Kennington, Mary Chernesky, Brent Broadus, Adrian Hunsberger, Marjorie Moore, Mary Keith, and Mike Davis

Minutes of the August 23, 2011 Summer Board meeting were taken by last year's secretary Robert Halman, and placed on-line. It was moved and seconded that they be approved; all were in favor.

Minutes of the August 30, 2011 annual General Membership Meeting were taken at the meeting by Andy Toelle, and left on a laptop. It is unclear which laptop they were left on, and at present, cannot be found. John Lily, Ray Mobley and Dan Culbert will attempt to reconstitute the 2011 annual meeting minutes in time for the 2012 annual meeting.

Minutes of the October 4, 2011 Fall Board Meeting had been distributed by email prior to the meeting. Mary Chernesky had suggested some corrections which were included by secretary Dan Culbert. Tracy Tesdall moved and Marjorie Moore seconded a motion to approve these minutes as corrected. All were in favor.

Treasurer's Report - Lori Wiggins provided an updated budget sheet for the meeting. Total <u>income</u> as of the meeting was \$5723.55: including 57 renewals (\$3420), 7 new members (\$490), 1 Life member (\$200); High 5 & 10 donations (\$175); EPAF action proceeds (\$888.02); National endowment donations (\$550) and interest income (\$0.53). <u>Expenses</u> paid totaled \$775.00: National endowment (\$550), reimbursement to Bay County of dues for retired member Ken Rudisill (\$60), registrations for ESP Award recipients (\$145).

Dan Culbert noted the budgeted funds to support the President's attendance at the 2010 National ESP Conference were not spent by the President. He suggested that the \$1200 could be split between the two delegates who did attend, Mary Keith and Dan Culbert. President Mobley asked if there were any objections, and did not receive any from the Board members present. It was moved by Marjorie Moore and seconded by Bren Broaddus to approve the treasure's report as submitted. All were in favor.

EPAF Report – President Ray Mobley announced that the next EPAF board meeting would be December 15 at McCarty Hall (UF), and asked if any other members could attend. He noted that ESP will be responsible for the opening ceremonies at EPAF next year (2012).

Committee Reports

President Ray Mobley officially made the appointment of committee chairs for 2011-12.

<u>Member Services Committee</u> Chair Adrian Hunsberger announced that the Deadline for Chapter Awards: application has been set for *Friday June 22, 2012*. She also noted that the 2011 chapter award winner applications would be forwarded for Regional competition on March 1, 2012, and that the Angus scholarship applications are due May 1, 2012. Almost all of these applications are competed on-line at <u>ESPnational.org</u>. She said it is critical for all Board members to let members know about our awards program to improve participation, and that she plans to send a couple of batch emails to all members.

Mary Keith, who serves on the National ESP Awards committee, said it is very important for all members applying on line to include Adrian's name and email on the application. As a backup, Mary suggests that applicants send a copy

of their completed (submitted) application to Adrian in order that the Chapter is aware of who has applied for an award. Dan suggested that Adam Putnam's Friend of Extension award application could benefit from some updating. Mary noted that 2011 chapter award winners can update their state applications on-line before the March 1 deadline prior to going on to Regional consideration. She said there is no limit on the number of supporting letters that can be submitted for the Friend of Extension Award. The national website has updated the website to accommodate the number of words that can be accepted in an application.

<u>Global Relations Committee</u> Chair Dan Culbert suggested that Extension staff interested in International work may wish to review the National ESP Connection Newsletter for articles about Global Relations opportunities and accomplishments. He noted that the UF/IFAS International Programs Advisory Team will hold its spring International Programs workshop on Wednesday March 21, 2012 @ Reitz Union.

<u>Membership Recruitment & Retention Committee</u> - Analyst Tracy Tesdall provided an updated membership list prior to the meeting. Active membership stands at 64 members plus two new active members and one new Life member. These numbers represent a 1/3 drop in membership, however, the deadline to accept new members in December 31. She noted that District Directors play a key role in retaining and recruiting new ESP members, and encouraged all Board members to make a push for memberships.

A new member from last year had inquired if she needed to send in additional membership fees even though she had just joined in mid 2011. Lori Wiggins noted that there is a definite disadvantage to new members who miss the December 31 deadline, as they will not be able to receive many of the benefits of memberships (awards, scholarships, etc.) Ray and Tracy both agreed to contact the member to let her know that she will need to submit a renewal application to keep her membership active.

<u>Retirees/Life Member Committee</u> Chair Mary Chernesky had submitted a report to the board before the meeting. She reported that there are plans by Linda Cook to produce three issues of the *Senior Moments* newsletter this year. She again asked if there were any suggestions for a new Life member committee chair; she had asked Ray Zerba, who said he was going to be occupied with other associations. Mary Beth Salisbury was also going to be asked; however, she will still be quite busy with her new responsibilities with Osceola County government.

Ray asked if ESP provides a letter of well wishes to newly retired Extension faculty. Mary Chernesky said that most of the time she is not able to obtain the addresses of the new retirees from IFAS personnel office. Our method of identifying retirees is to review the Extension Comings and Goings newsletter or by word of mouth, but neither of these methods is a reliable way to contact retirees after they have left service.

Ray suggested that the communication of impending retirements from our District Directors is a critical function of those Board members. He would still like to send a letter to retirees, and will be in touch with the UF Dean for Extension to see if the IFAS Personnel office can provide a greater level of communication with ESP.

An important task for the ESP Board was identified as how to maintain the involvement of retirees in the profession.

<u>EPAF Memorial Service</u>: Chaplin Will Sheftall announced that he has been made aware of 9 former Extension faculty who passed on since EPAF, and that they will be honored at the 2012 memorial service. Mary Chernesky noted there many of these persons were both long-time Extension employees and long-time retirees.

<u>Public Issues</u> Chair Robert Halman was not in attendance, but indicted that he was planning to attend the PILD workshop in Alexandria Virginia in April 2012.

Nominating committee Chair Joan Bradshaw did not have a report at this time.

<u>Annual Report Committee</u> Chair Dan Culbert said the 2011 Annual report is on-line. Additional back issues of previous year's reports have been located, and a few have now been posted. He indicated he would be happy to have another person take on the responsibilities of compiling the annual report if there was anyone interested.

<u>Constitution and Bylaws</u> Chair Brent Broaddus said there may be a need to make some by-Law changes concerning District Director replacements and the reinstatement fee. (See New Business - below)

Professional Improvement/Abstracts. Katherine Allen did not have a report at this time.

<u>Website Committee</u> Chair Dan Culbert said that Scott Jackson (Bay County) may be interested in serving as the ESP webmaster. He will be contacting him to see if he is interested in taking on this role.

<u>Resource Management (Foundation)</u> Chair Marjorie Moore did not present a report.

Old Business:

<u>ESP Annual Conference</u> - Mary Keith & Dan Culbert attended the conference in October. It was held in Syracuse NY, hosted by Cornell, University. The Alpha Delta Chapter was presented Platinum Chapter of Merit recognition (for overall ESP programs) and earned a Platinum Award for Achievement in Chapter Membership. Dan Culbert was named the only 2011 US Regional winner of the <u>International Service</u> <u>Award</u> at the Syracuse Conference, presented a concurrent session, and served as on the national Global Relations Committee. Mary Keith served as a member of the National Awards Committee. Next year's conference will be in Mobile Alabama, and because it is so close, presents a good opportunity for Alpha Delta members to participate in the professional development opportunities available at the Conference.

New Business:

<u>NE District Director vacancy</u> - Brent Broadus noted that Terry DelValle has resigned he position as ESP District Director, and has recruited Mike Davis to serve as the new Director. He stated there is a difference between the By-laws and the Standing rules concerning the process as follows:

By-Law Article V section: "the Board of Directors (Officers plus District Directors) appoints replacements for officers, including District Directors." However, the *Standing Rules state* "All other officer vacancies will be filled by presidential appointment, ratified by the Board of Directors."

It is also unclear if the District Directors are considered officers or not. In case of a change in District Director, the By-Laws state that the new appointee will fill the remainder of the term, and then enter the normal rotation. Brent indicated he would be submitting a proposal to change the Rules or By-laws that would need ratification at the Septembers 2012 General meeting.

Ray offered to resolve the issue by appointing Mike Davis effective immediately as NE District director. Dan Culbert moved and Lori Wiggins seconded a motion to approve Ray's suggestion to appoint Mike Davis. Motion was carried unanimously.

<u>Reinstatement Fee</u> – a question has been raised as to keep this fee or not. Mary says that we should enforce the fee, although the constitution indicates that Life members would be exempt from the reinstatement fees. Active members must pay the fee in order for their membership rights to become reinstated. Lori said that there have been a few members who have paid the fee in the past. Would there be an effect on membership renewals? Would we lose members or create problems if the rules are not uniformly applied? Dan said that there is value in examining this issue, but specific language for a proposal would need to be on the table for the issue to be adequately discussed. Ray suggested we may need two proposals for the purpose of discussion.

National Officers sought: two national leadership opportunities available to Southern region: <u>Southern Regional</u> <u>Vice President</u> - term is two years; also serves as chair of National Resource Development & Management Committee. Nomination/application due 1/2/2012. The <u>Second Vice President Position</u> is a four year commitment starting with second vice president, moving to first vice president/president elect, national president and past

president (serving in each capacity for one year). The Nomination/applications are due 7/1/2012. Travel expenses are covered by National ESP; will be elected at the 2012 ESP Conference in Mobile.

Upcoming Special Events

<u>JCEP</u> - February 7 - 9, 2012, San Antonio, Texas. Ray Mobley and Tracy Tesdall will be attending JCEP. The Chapter Annual Report for JCEP Conference is due Jan. 28TH. Dan agreed to compile the official Alpha Delta Chapter report and post it on the National ESP website in time to meet the deadline.

PILD April 16-18, 2012 Westin Alexandria, VA – Robert Halman has indicated an interest in attending.

<u>ESP National Conference</u> - October 7-10, 2012, Mobile, AL. Request for proposals (Concurrent session speakers or posters) is due 3/15/2012. Proposals can be posted on the National website.

NAE4-HA National Conference - October 21-25, Orlando FL

District Director Reports

<u>NW District</u> Director Marcus Boston said he will be emailing his report to the Board.

<u>NE District</u> Director Mike Davis *(welcome aboard Mike!)* said that a realignment of the counties supervised by the District Extension Directors now puts Putnam County in the North East District. He is aware of 16 potential new members that will be contacted. Linda Landrum will be retiring January 1, 2012, and he has her home address. While most county budgets are expected to be flat, Dixie County is expecting a 15% reduction.

<u>Central District</u> Director Mary Sue Kennington reported that Brevard County will be "moving" to the South District, and that Brevard CED Jim Fletcher will be the acting CED for Osceola County. She reported that Keri Leymaster has been appointed as the new Orange County Residential Horticulture agent. Osceola County has received a grant to address the needs of homeless clientele, especially students. Dan Cantliffe has been appointed CED in St. John's County.

<u>South Central District</u> Director David Shibles was not in attendance, but Brent Broaddus noted that Hillsborough would be starting a new 4-H agent in the new year, and that Nicole Walker was just appointed Polk County CED.

<u>South District</u> Director Gene McAvoy did not provide a report. Brent noted that new 4-H agents are expected in Broward, Palm Beach and Highlands counties.

<u>State Director</u> Amy Harder was not able to provide a report. There is still a need to focus on the value of ESP to state specialists as a means to improving membership among this group of faculty.

Announcements, Questions or Concerns

Board members may wish to look at the new District boundaries to see how it will impact ESP Districts.

Mary Sue Kennington said that one impediment to new members was that some faculty could not afford the membership fees for more than one Professional association. Most often, the "subject matter association" is the priority membership. She also noted that in the past and in other states, ESP membership was seen as special. The emphasis on our organization as being an honorary fraternity is not emphasized as was previously. Mary Chernesky observed that we are not the same proud and privileged organization that we once were, and that it affects membership.

Dan observed that providing more professional improvement opportunities may improve the value of membership. He observed that we can invite National Board members to visit our meeting, and would be happy to do so.

Mike Davis said that at TAMU there is a need for specialist to collaborate with Extension staff when they do their research, and that specialists join to become familiar with the agents. Department heads encouraged ESP membership as essential.

A useful question may be to see if our state's percentage of potential membership is different from that of other Extension professional associations and in other states.

Ray asked us to consider what strategies we can articulate to improve specialist and agent involvement, and to examine our image to see if it is a reflection of what we want it to be.

Having no further business, Tracy Tesdall moved and Brent Broadus seconded a motion to adjourn. All were in favor; meeting adjourned at 12:34 pm.

Minutes

The meeting was called to order by President Ray Mobley at 1:03 PM. The draft agenda was reviews and approved.

The following Board members were present: Ray Mobley, Robert Halman, Dan Culbert, Tracy Tesdall, Will Sheftall, *Mike* Davis, Mary Chernesky, Katherine Allen, and Dr. Marjorie Moore. Joy Jordan attended as a guest.

Minutes of the December 8, 2011 board meeting were approved, pending any minor corrections. Board members were requested to provide any such changes to Secretary Dan Culbert.

It was noted that no computer files or notes that were taken at the last General Membership Meeting can be located; Dan Culbert will attempt to reconstruct meeting notes from the annual report in lieu of official minutes.

Treasurer Lori Wiggins was not able to attend, but had sent word that the report has not changed since the December 8 board meeting. Actual Income as of that date was \$5723.55, and expenses were \$695.00.

- EPAF Report Ray Mobley reported that ESP is responsible for the EPAF Opening ceremony. Mary Chernesky inquired about the scheduling of the Retiree/Friends luncheon. Marjorie Moore asked if the meeting site will be changed it was reported that this will be the last year for the contract with the Buena Vista Palace in Orlando, and the site may be changed in 2013. It is strongly suggested that a new contract be secured for 2013 ASAP, and not to wait to begin the negotiations. Ray said he will request that minutes of the EPAF Board meetings would be sent to the ESP Board members. It was unknown at that time if there would be financial support from the Extension Dean to support some of the costs of EPAF due to budget constraints.
- It was also noted that the meeting of the Florida Association of County Commissioners was to be held in Orlando June 19-21. Board members agreed informally to support personal contributions to produce a ESP basket as a raffle item. Marjorie said she would ask Mary Sue Kennington if she would be willing to accept these donations and assemble a suitable basket, and insure that it was delivered to the commissioner's conference. Suggested contributions of \$10-20 could be made directly to Mary Sue.

Committee Reports

Member Services Chair Adrian Hunsberger was not able to attend the meeting. Nominations for Awards need to be completed online with email follow-up notifications sent to Adrian by June 22. Nadia Torres was suggested as a nominee for the Friend of Extension, however, as an Extension employee she would not be eligible, she would be possibly a candidate for the Administrative Leadership awards, but since she has not paid dues she could not receive that recognition either. President Ray Mobley urged all members to apply for awards to insure that no recognition category is unfilled.

Global Relations - Ray Mobley indicated that he traveled to Haiti in February in support of FAMU programs. Dan Culbert reported the IFAS IPAT committee International Workshop was held on March 21, with keynote presentations on IFAS Haiti programs; they were followed up by workshops on other IFAS Global projects and opportunities in Haiti, Mozambique, Tanzania, and the Middle East, plus others on a Peace Corps training program and the global Extension program, MEAS. Marion County Extension Agent III Norma R. Samuel (and a new ESP member) was recognized as the winner of the 2011 IFAS Award for Excellence in Internationalizing Extension. Samuel and Culbert have submitted a poster proposal on the MEAS program to be presented at the Mobile ESP conference. Eight IFAS Extension faculty traveled to Costa Rica in early March on a professional improvement program to study sustainability; it was funded in part by a National ESP scholarship awarded to Terry DelValle. Analyst Tracy Tesdall gave the Membership report: as of April 2, we had 99 active members, including 9 new members and one new Life member so fat for this year.

Retirees/Life Member Chair Mary Chernesky nominated Linda Cook (current retiree newsletter editor) as the next ESP Retiree Life Member Representative & Joy Jordan as the next *Senior Times* Newsletter editor. It was moved by Will Sheftall and seconded by Mary Chernesky that Joy and Linda would assume these responsibilities for ESP effective 9/1/12. All were in favor. Mary welcomed Joy Jordan as a nominee for the new editor of the *Senior Times* Newsletter. She reported that the next issue of *Senior Times* will be sent in June with the invitation to attend EPAF to all know retirees. A county office will again be needed to assist in mailing the *Senior Times* newsletter. She was asked the approximate number of newsletter that needs to be mailed, and responded that the current retiree list is about 160 persons. Joy Jordan agreed to review the latest Life member and IFAS retiree mailing lists to see if she knows of any other changes.

President elect Robert Halman attended the Public Issues Leadership development conference in Washington DC. He reported that each Extension association was represented in the Florida delegation. A webinar is provided to teach each delegate how to be more effective when meeting with national legislators. Southwest Florida agents have not been able to set up visits with the Florida representatives. The Dean does provide some financial support for those attending. The program includes a state's night out, an Association nite plus a White House tour - Robert said he is looking forward to meeting Mrs. Obama. Robert is preparing a presentation on some of the work being done in Immokalee, entitled "Turning the Tide."

Past President Joan Bradshaw was not present to provide any update or discussion on nominations for next year's Board members.

Dan Culbert will again be preparing the ESP Annual Report for 2012.

Constitution and Bylaws Chair Brent Broaddus did not provide any report. The Board requests that he review minutes and notes to see if any needed changes to the organizational documents are needed, and provide draft language in time for notification at the Annual meeting.

Professional Improvement Chair Katherine Allen reported that Abstracts for EPAF presentations are due May 4, and need to be uploaded to the IFAS SharePoint site. ESP will have 13 slots reserved for its members, and our members are needed to submit topics related to Administrative skills and Leadership topics. They will be evaluated by a committee of 4 agents who selecting those that will be presented. Minimum evaluation scores for acceptance are 40/50. Presentations will be given on Wednesday August 29 in Orlando. Tracy asked if the RFP date is earlier this year; Katherine agreed, but did not know why this announcement was moved up.

Dan Culbert reported that he is still updating and maintaining the ESP Website. He is willing to provide this task to another willing person who would like to become more involved in ESP.

Resource Management Chair Marjorie Moore (Foundation) reminded members to provide whatever support they can to the Chapter and National ESP Funds.

Old Business:

Tracy Tesdall & Ray Mobley attended the JCEP Conference in February. Tracy reported that at the ESP meeting during the JCEP conference, chapter reports were given, focusing on membership & marketing successes. States were also asked to share what they were doing to celebrate the Morrill Act in 2012 and the Smith-Lever Act in 2014. Good ideas shared included creating an email tagline for faculty to use and a PowerPoint slide to end every presentation by faculty across the state. The Southern Region is looking for a 2nd VP and chapter articles for the *ESP Connection*. Overall, it was a good meeting and an excellent opportunity for networking

New Business:

The 2012 ESP Annual Conference will be held in nearby Mobile, Alabama in October. At this point, Mary Keith & Dan Culbert will be attending as they will be serving on National ESP committees and have submitted abstracts of Posters at that conference.

Future dates and locations are 2013 – Galaxy IV – Pittsburg, PA; 2014 – Indiana; and 2015 Idaho.

Volunteers are needed for the Farm Bureau dinner in Gainesville, to be held Tuesday, August 7, 2011. Especially needed is set up from 3 - 4PM. Please contact Ray Mobley if you can assist.

District Director Reports were received from NE District Director Mike Davis and State District Director Amy Harder.

Announcements, Questions or Concerns

Mary Chernesky discussed some of the concerns expressed by Mike McKinney to the National ESP Board. Mike observed that retirees add a considerable impact to ESP as they represent more than half of national membership. It is important that the organization returns this benefit to the Life members and that the organizations stay up to date with the needs of its members. While the push from National is to "come to the National meeting", he felt it is not relevant to retired members. Mike has felt that when these concerns were brought to the National Board, these concerns were brushed off. Mary said it is time for an examination of why Life members would want to belong, and those reasons must relate to what is of interest to retirees. What is done in Florida for Extension retirees all relates to ongoing EPAF activities, and these are not structured to require ESP membership. It may be time to put a survey, possibly in our Senior Times Newsletter, asking retirees to outline what their concerns are and what kinds of services the chapter can offer. Mary feels that IFAS and Extension are losing good supporters by not talking with retirees. This topic needs more discussion and hopefully it can be put on the agenda for the next meeting.

Dan has suggested that a National ESP officer should be invited to EPAF and the Alpha Delta chapter meeting. He will work with Ray and determine what it will take and report back at a future board meeting.

Date of Next meeting was projected for early to mid June. A motion to adjourn was made by Mary Chernesky and seconded by Marjorie Moore. All were in favor. Meeting adjourned 2:20 PM.

The meeting was called to order by President Ray Mobley at 2:02 PM. Members approved the agenda. Chaplin Will Sheftall provided a thought for the day: "There is no one so disadvantaged as those without the skills of poverty."

Secretary Dan Culbert called the roll; the following Board members were in attendance: Ray Mobley, Robert Halman, Lori Wiggins, Dan Culbert, Tracy Tesdall, William Sheftall, Joan Bradshaw, Mike Davis, David Shibles, Mary Chernesky, Brent Broaddus and Adrian Hunsberger.

Minutes from the April 2, 2012 board meeting were sent prior to the meeting by Secretary Dan Culbert. Mary Chernesky provided some corrections. It was moved by Robert Halman and seconded by Joan Bradshaw that the minutes be approved as corrected. All were in favor. Culbert noted that he has drafted some notes from a review of Annual report for the General Membership Meeting August 30, 2011. He urged members to review and provide him with any suggestions or corrections within the next week.

Treasurer Lori Wiggins had sent a report prior to the meeting. Actual income was reported as \$8413.97 and expenses listed were \$5953.67. Culbert asked if Halman had received any reimbursement form the chapter for his PILD expenses, he reported that his costs were covered by other funding. Culbert also noted that the report did not reflect payments made to himself and Mary Keith to help pay for National Conference expenses. Upcoming EPAF expenses had not yet been included for plaques, initiation pins, and guest registrations. These costs may not be reflected in the budget report to be presented at the Chapter annual meeting. Board members were asked to be alert for any changes needed for next year's Budget, and refer them to the Treasurer.

Ray Mobley, Robert Halman, Joan Bradshaw and Mary Chernesky contributed to the EPAF Committee Update. ESP is scheduled for the opening EPAF Assembly, but the agenda for this year's EPAF conference does not have such an event scheduled. Ray said he has assembled a group of ticket takers for the Thursday program. For the Tuesday Awards breakfast, winners are asked to assemble at the side of the stage prior to their presentations. Tracy Tesdall will be assembling an members information exhibit for the trade show, and will be putting together the new member Initiation program for our Tuesday morning ESP annual meeting. Will Sheftall is finalizing the Memorial Service to be held during the Tuesday luncheon. Members are urged to assemble items for the Wednesday night EPAF auction and submit information about their donations to Les Harrison or Matthew Orwat.

Committee Reports

Member Services Chair Adrian Hunsberger had sent her report prior to the meeting. She said she was happy with the number of Award applications received this year, and noted that in some cases there was competition for the Awards. She needed the assistance of the board in knowing which awards are to be presented at which EPAF program. Alex Bolgues is the Southern Regional International Service winner, and will be receiving that recognition at the ESP conference in Mobile, but mention of that award should also be made at the Awards Breakfast. Adrian will make the awards presentation to the Chapter's International Service Award winner. Ray Mobley will make the presentations of the DSA winners at the Tuesday nite DSA banquet. We are not sure when the Early Career Award. Mid Career or Continued Excellence Award presentations will be made. Adrian will provide copies of the award applications and the bios to Ray Mobley for him to use in preparing his remarks for those presentations. The nominator of the Meritorious Support Service Award winner, John Lily, will make that presentation. Mary Chernesky will present the Chapter Retiree Service award at the Tuesday Luncheon. The Friend of Extension nominator, Joan Bradshaw, will make that presentation also at Tuesday Luncheon. The Awards Chair was requested to review these suggestions with Becky Jordi who is coordinating the EPAF Programs. Funds for the meals for the Friend of Extension and any guest/ spouse will be covered by ESP. The Retiree Service Award winner's meal should not be a charged as it is covered in the retirees' registration. EPAF will bill ESP after the conference for these costs. Last year, Treasurer Lori Wiggins reported that we paid \$145 for these award winner meals last year, but we are not sure which

award winners were paid for. The board asked Lori to request from the EPAF treasurer an itemization of these meals to insure that we are not charged for meals not owed. Adrian has ordered the plaques and they should be sent to her next week. She also has received a written report from last year's Nadine Hackler Chapter Scholarship winner and will ask Elaine Courtney to make a brief presentation at the ESP business meeting. Terry DelValle received a Richard Angus National ESP scholarship Award last year. Dan will ask her to also make some brief remarks at our ESP Annual meeting.

Dan Culbert provided a brief Global Relations report. He noted that 8 Extension faculty made a professional development tour of Costa Rica in March, and that one agent received financial support from National ESP through the Angus Scholarship. He said he will be stepping down as the county extension representative to the IFAS IPAT committee after 4 years, and is looking to make suggestions to our new Dean on a suitable replacement. Culbert noted that that the IPAT committee honored Norma Samuel with 2011 Award for Excellence in Internationalizing Extension, and that she will also be our Chapter's ESP International Service Award winner. She and Culbert will be presenting a poster on the Modernizing Extension and Advisory Services (MEAS) grant program at the ESP conference in Mobile. MEAS is developing materials to assist Extension programs in other countries, and UF is a partner in this consortium.

Analyst Tracy Tesdall gave a brief Membership report. Our membership for the year is 100 active members, including 10 new members that will be inducted at this year's Annual meeting. We have two new Life members this year, and our life membership is 120, discounting 5 life members that have passed away this year. Our current total chapter membership is 224. She will be sending out an email to all current members suggesting they can renew their memberships now for next year. Katherine Allen had also requested that we send renewal invoice to membership with Annual meeting notice!

Retirees/Life Member Chair Mary Chernesky sent a report prior to the board meeting. She noted that she is stepping down as Life member chair at EPAF, and that Linda Cook will be stepping up after the EPAF meeting. She continues to have difficulty getting the addresses of IFAS retirees from administration. A summer 2012 issue of *Senior Times* Newsletter has been sent out by Editor Linda Cook, and Joy Jordan has volunteered to be the editor of that important publication for next year.

Chaplin Will Sheftall had sent his report on those who will be recognized at this year's EPAF Memorial Service. He will use the template used by Tracy Tesdall last year. He suggested that the obituaries for the 12 honorees could be posted on the ESP webpage rather than included in the Annual report as it is quite lengthy. He is still trying to hunt down photographs for 6 persons. He asked if the Chapter offers condolences to the families of departed members. The board feels that sending flowers to departed Life members would be cost prohibitive, but it would be a supportive gesture for the Chaplin to send a note of condolences to the families of the departed. A copy of the EPAF memorial service program could also be sent on as well. ESP imprinted cards are available for this action.

Robert Halman had sent a Public Issues committee report on the PILD conference. He noted that Mary Ann Goza and DED Charlie Vavrina gave leadership to the IFAS Extension PILD team. There were lots of ideas developed for pre-conference organization. Budget funds to support this effort may be able to be found in Extension funds in the future. There is a need for funds to provide for legislative "gifts" or tokens that are presented to the Congressional staffers and officials that meet with the Florida PILD team. Becky Jordi will be giving a presentation on this subject at EPAF.

Mary Sue Kennington had also sent a report summarizing the participation in our ESP basket that the "Country Store" raffled off during the Florida Association of Counties conference.

Joan Bradshaw had not yet come up with a nomination for the incoming Chaplin for next year. She suggested that our pool of District Directors would be a good place to look, as they are familiar with the workings of the Chapter. She asked NE District Director Mike Davis if he would be interested in entering the ESP officer rotation. He indicated he would be, but did not want to create a vacancy in the District Director spot. He agreed to ask around the District to

locate a member willing to take over that seat, and Joan mentioned that if he could not find someone else, that she would be willing to serve as a the NE District Director, as Citrus County has been moved into that district.

Dan Culbert reported that he has received most of the necessary information from almost all persons for the Annual Report. The deadline for all others to send their reports is Friday August 17. He will compile the report and post it online by mid week before EPAF. He would only be printing up a limited number of copies for the board members and Life members attending the meeting that do not have internet service.

Constitution and Bylaws Chair Brent Broaddus sent a report prior to the meeting. He outlined two proposed changes in the By-Laws that would insure that the By-Laws and the Standing Rules conform to each other. One proposed By-Law change was to specify a member reinstatement fee and the other was to clarify the procedures to be used in case of an officer vacancy. A clarification in the Standing Rules to specify the voting delegates to the National ESP meeting was also being sent forward. Since there is no language in either of these documents as to how changes of this nature are to be made, he suggested that they be offered for approval by a simple majority of the members at the Annual meeting.

Professional Improvement Chair Katherine Allen had sent her report of the EPAF Abstracts. Her committee reviewed 29 abstract submissions and selected 16 for presentation. She called for special thanks to the committee members and to Joy Hazell, EPAF abstract Chair for her guidance and direction.

Dan Culbert will continue to make changes to the Alpha Delta Website, but has received word that Bay County Sea Grant Agent Scott Jackson is agreeable to become the new Website manager. They will meet at EPAF to discuss the transition, and Scott will need to be appointed as the new Website manager at the annual meeting. Dan will also prepare a certificate of appreciation from the chapter to Ligia Ortega, the IT specialist that was responsible for creating the new look for our website.

Resource Management (Foundation) Chair Marjorie Moore - sent her report, and it contained the wonderful news that the Alpha Delta Chapter has exceeded its \$12,500 pledge to the National ESP Endowment fund.

Old Business:

Tracy Tesdall & Ray Mobley had previously reported on their attendance at the JCEP Conference held in San Antonio. Their report will be included in the annual report.

Joan Bradshaw attended the Farm Bureau appreciation dinner in Gainesville on Tuesday, August 7, 2012. She reported that the program was well received by the 50 – 60 Farm Bureau members present. IFAS administrators in attendance included Interim Dean Tom Obreza and Associate Dean Joan Dusky. All agreed that Pat Hogue and the FACAA cooking crew again produced a wonderful meal. She noted that it is important to hold this event to thank the Farm Bureau for all they do to support Extension work throughout Florida.

New Business:

The following members are planning to attend the 2012 ESP Annual Conference in Mobile Alabama in October: Ray Mobley, Dan Culbert, Mary Keith, Alex Bolques, Norma Samuel, and Pete Vergot. Our New Extension Dean Dr. Nick Place will also be there. Dan Culbert noted that our chapter needs to designate our (2) voting delegates to the National ESP business meeting. Ray and Robert will meet to designate the chapter's voting delegates.

In order that the Chapter's work is done more efficiently, Dan Culbert encouraged the appointment and or reappointment of all committee chairs during the ESP Annual meeting. Our By-Laws state that the President makes such appointments and our incoming President Robert Halman expressed a willingness to do so. Robert said that since he will be President of ESP and Vice-Chair of the EPAF board next year, he will be stepping down as the Chapter Public Issues committee Chair. Adrian Hunsberger has also expressed a desire to step

down as Member Services chair. Both are key leaders, and we will need to find replacements before our annual meeting.

Dan Culbert had made some inquiries as to what it would take to invite a National ESP officer to visit us at EPAF. The policy of the National Board is to make such visits no more than once every five years, and the expectation is that the costs of room and board would be paid for by the Chapter. Such costs this year would be close to \$1000. It was determined that it would be too late for such a visit for this year, and that the funds to offer this invitation would need to be included in the ESP budget. An ESP Professional Mini-grant could also be applied for by the chapter, and if approved could be used to underwrite those costs of EPAF registration and hotel charges. There are a number of National officer changes anticipated in October, i.e. a new Second Vice President that will come from the Southern region, plus a new Southern Regional Vice President. Therefore it would be best to wait until these nearby officers are on board. The invitation could also include a request for the officer to conduct a Professional Improvement workshop at EPAF to make it a more useful visit. Mary Chernesky asked that such a visit ought to include a discussion on what are the Life member benefits for ESP members, and this would be useful in improving the number of retirees becoming ESP Life members.

The idea of creating an ESP Committee Handbook was also introduced. Bill Heltemes, the Regional Specialized 4-H Agent would be retiring as to September 17th. Overall, counties were reporting flat budgets or small decreases.

Central District Director Mary Sue Kennington provided a report prior to the meeting.

South Central District Director David Shibles had sent his report, and observed that things were pretty stable across the district. He noted there were lots of potential new ESP members that need to be asked in his area. After a long period of vacancy, DeSoto County finally has a CED, and he noted the replacement of the Hillsborough County CED Debra Kinsella with Interim CED Stephen Gran, who does not have an Extension background. The SFWMD had been providing a considerable amount of funding for FYN/FFL programming; these funds were expected to dry up and would have an effect on the number of Extension faculty in the district.

Gene McAvoy had sent on a South District report prior to the meeting.

State District Director Dr. Amy Harder did not send on a report as she has been out of the office, but had expressed continuing difficulties getting information from the various department sand RECs.

Announcements, Questions or Concerns

Board members were asked if they needed any AV equipment for EPAF presentations. All are encouraged to bring their own laptops, and if they can spare it, bring LCD projectors or screens. Ed Skvarch is again Equipment Chair for EPAF and should be contacted well before the conference if difficulties are anticipated,

Since the notes taken by Andy Tolle have never been located and minutes for the last annual meeting were not taken, Dan Culbert has compiled as set of "notes" that have been distributed to the board members. If there are any

additions or corrections, please send them on to him ASAP. The "Notes" will be printed in the Annual report in lieu of official minutes of last year's annual meeting.

A motion to adjourn was made by Mike Davis and seconded by Dan Culbert. Motion was passed, and meeting was adjourned by President Ray Mobley at 3:45 PM.

ALPHA DELTA CHAPTER CONSITITUTION

Article I - Name

The name of this organization shall be the Alpha Delta Chapter, Epsilon Sigma Phi, National Extension Fraternity.

Article II - Purpose

Section A

The purpose of this association shall be exclusively charitable and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Section B

This purpose includes, but is not limited to:

1. maintaining the standards and ideals, preserving the traditions and upholding the morale, prestige and respect of the Cooperative Extension Service; and,

2. developing an effective working relationship and a spirit of fraternal fellowship among the present and past employees of the Cooperative Extension Service.

Article III - Membership

Section A

Qualifications:

1. duly elected faculty, professional and administrative staff who have held full or part-time Extension appointments for a total of three or more years (the three-year requirement does not apply to ESP members in other states transferring to Florida); and,

2. have displayed a cooperative and helpful attitude toward fellow Extension employees, demonstrated competency in assigned fields of responsibility; and,

3. exhibited ability in educational techniques essential to the conduct of an effective Extension program.

Section B

Classification:

1. Active: Active members are those who are engaged in professional Extension work and who have met all qualifications of membership;

2. Life: Active Alpha Delta Chapter members may become life members upon their retirement from Extension work.

Section C

Election:

1. Membership shall be on the basis of a ninety percent (90%) favorable vote by the eligible voters who properly mark and cast their ballot.

Section D

Eligible Voters - All active members.

Section E

Voting:

1. Membership voting may be taken by mail, an alternative method or at any annual or called meeting or a combination in compliance with the requirements stated below; and,

2. The vote shall be reported not later than at the next annual meeting of the fraternity after the membership has been proposed.

3. Alternative provisions for the process of the membership to cast their votes shall be adopted at the discretion of the board of directors.

Section F

Membership Criteria

1. Acceptance of membership by the newly elected member shall be acknowledged in writing and accompanied by the initiation fee, prior to the date of initiation; and,

2. A person may withdraw from membership by notifying the Secretary in writing; and,

3. Any member who fails to pay annual dues shall be dropped from membership in the fraternity and shall be so notified in writing by the Secretary; and,

4. Any member may be expelled from the fraternity for failure to observe the obligation or for conduct unbecoming a member of the fraternity; and,

5. Charges may be referred in writing, signed by two members; and,

6. These charges shall be reviewed by the membership committee which will investigate the charges and report to the fraternity, making a recommendation and,

7. An accused member shall have right of personal hearing and to file evidence in regard to preferred charges; and,

8. Expulsion from the fraternity shall require that three-fourths of all eligible voters, as defined above, cast their ballots with a simple majority showing support of the motion to expel.

9. Reinstatement - Any member whose membership has lapsed may be reinstated by paying regular dues and a reinstatement fee of \$10.00. Retirees are exempt from paying the reinstatement fee.

Article IV - Officers

The officers of this organization shall consist of a President, President-Elect, Secretary, Treasurer, Annalist, Chaplain and Immediate Past President.

Article V - Meetings and a Quorum

Section A

An annual meeting shall be at the time of the annual Extension Professional Associations of Florida, Inc. meeting.

Section B

Special meetings shall be held upon call of the President or upon written request of twenty percent of the members.

Section C

A Quorum - 15% of the paid membership shall be present to constitute a quorum at any called or special meeting of the membership.

Article VI - Initiation Fees and Dues and Changes

Section A

Initiation fee - For this chapter it shall be set annually and will include state and national dues for one year.

Section B

State and National Dues - Shall be payable to the Secretary prior to the annual chapter meeting.

Section C

Changes - Made by the National Council in dues and/or fees will automatically apply to the local chapter.

Article VII - Emblem and Membership Card

Section A

The official emblem shall be that adapted by the National Council of Epsilon Sigma Phi.

Section B

Each member will be provided with a membership card signed by the local chapter secretary and the national organization secretary.

Article VIII - Amendments

This Constitution may be amended at any annual or special meeting by a two-thirds vote of the members present providing members were notified of suggested changes thirty days prior to the meeting.

ALPHA DELTA CHAPTER BYLAWS

ARTICLE I – Name and Mission

Section 1. Name:

The name of this organization shall be Alpha Delta Chapter, Epsilon Sigma Phi, The National Honorary Extension Fraternity, herein referred to as ESP.

Section 2. Mission:

ESP is dedicated to fostering the standards of excellence in the Extension System and developing the Extension Profession and professional.

ARTICLE II - Purpose

Section 1. Purpose:

The purpose of ESP is:

a. to serve exclusively as a charitable and educational organization within the meaning of Section 501(c)(3) of the Internal Revenue code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

b. to recognize excellence in the Extension community.

c. to provide opportunity for networking, fellowship and collaborative efforts.

d. to foster leadership development through mentoring Extension professionals in the philosophy and professional practice of Extension education.

e. to facilitate professional development.

ARTICLE III – Membership

Epsilon Sigma Phi is an equal opportunity/affirmative action fraternity. Epsilon Sigma Phi is committed to the active involvement of all its members regardless of race, color, sex, age, religion, national origin, disability, or veteran status. Epsilon Sigma Phi values and seeks a diverse membership.

Section 1. Qualifications:

The membership of ESP shall consist of duly installed faculty, professional and administrative staff who have held full or part-time Extension appointments for a total of three or more years on June 1, and who shall have displayed a cooperative and helpful attitude toward fellow Extension employees, demonstrated competency in assigned fields of responsibility, and exhibited ability in educational techniques essential to the conduct of an effective Extension program.

Section 2. Classes:

There shall be three classes of membership: A) member, B) honorary, and C) life.

- a. MEMBER. An Extension professional (currently employed by or retired from an entity of the Cooperative Extension System) has exhibited excellence in programming and leadership. Members continue to provide leadership and excellence in Extension programming throughout their career and during retirement.
- b. HONORARY. May be named upon recommendation of the ESP officers and approval by two-thirds of members present and voting at the annual meeting of the Chapter. Honorary members will not pay membership dues to the Alpha Delta Chapter. A proposal of honorary membership must be accompanied by a detailed statement showing the "meritorious service" it is proposed to recognize.
- c. LIFE MEMBERSHIP. Members who are retired from the Cooperative Extension System, may obtain a paid-up life membership by paying an amount equal to five times the National dues at the time of the purchase of paid-up life membership or may be made as installment payments over a two year period. These members hold equal rights and privileges to those paying annual dues.

Section 3. Transfer of Membership:

Active members in good standing in another chapter of Epsilon Sigma Phi may transfer upon:

- a. making request to Alpha Delta Chapter.
- b. paying initiation fee and being initiated.
- c. paying annual dues.

Section 4. Termination of membership:

After one year of non-payment of dues, membership in ESP will be terminated. A person can be reinstated by payment of dues.

ARTICLE IV - Business

Section 1. Fiscal Year:

The fiscal year of Alpha Delta Chapter shall begin on the first day of October and end on September 30 of the following year.

Section 2. Meetings:

The annual meeting of the Alpha Delta Chapter shall be held in conjunction with the Extension Professional Associations of Florida, Inc. meeting. Special meetings may be called by the President or upon written request of twenty percent of the members.

Section 3. Place of Business:

The principal place of business of the Alpha Delta Chapter, Epsilon Sigma Phi, shall be the University of Florida, Gainesville, Florida.

ARTICLE V - Officers, Directors, and Elections

Section 1. Officers:

The officers of ESP are: President, President-Elect, Secretary, Treasurer, Annalist, Chaplain, and Immediate Past President.

Section 2. Directors:

The directors are: one from each Extension administrative district, one from state faculty, and one from life members/retirees.

Section 3. Terms of Office:

The Treasurer shall be appointed annually by the President with the ratification of the membership with the option of re-appointment. All other officers are elected annually. District Directors serve a two-year term with half elected each year, according to the standing rules.

Section 4. Election:

The nominating committee shall present a slate of officers at the annual business meeting. ESP members present will vote, with election by majority vote.

Section 5. Assumption of Duties:

The officers and directors will assume their duties upon adjournment of the annual meeting at which they are elected. In the event of no annual meeting, the officers and directors will assume their duties at the conclusion of the election by mail (postal or electronically) or some alternative process approved by the Board of Directors.

Section 6. Filling Vacancies:

In the event of a vacancy, Board of Directors shall appoint a member to complete the term of office.

ARTICLE VI – Functions of Officers and Directors

Section 1. President:

The President shall preside at all ESP meetings. The President shall appoint all chairs and committee members necessary to carry out the business of ESP.

Section 2. President-Elect:

The President-Elect shall assume the duties of the President in his/her absence. The President-Elect shall appoint a Co-chair of each standing committee, who will become the chair the following year.

Section 3. Secretary:

The Secretary shall keep accurate records of honorary members and all meetings of the Executive Board and annual business meeting.

Section 4. Treasurer:

The Treasurer shall keep the official record of all membership and an accurate record of all monies. He/she shall also serve as chair and liaison between the Finance Committee and the Board of Directors.

Section 5. Annalist:

The Annalist shall serve as Chair of the Membership Recruitment and Retention Committee. He/she shall be responsible for keeping updated biographical information on each member.

Section 6. Chaplain:

The Chaplain shall have official charge of all religious and memorial services.

Section 7. Directors:

Directors will represent the area in which they serve, attend Board meetings, and encourage membership and participation of members.

Section 8. Immediate Past President:

The Immediate Past President shall give counsel to the Board of Directors, chairs nominating committee.

ARTICLE VII - Board Of Directors

Section 1. Members:

The Board of Directors shall consist of fourteen (14) members.

- a. Officers (6) President, President-Elect, Secretary, Treasurer, Annalist, Chaplain
- b. The immediate Past President
- c. The seven (7) directors (5 Extension Districts, 1 state faculty, 1 retiree)

Section 2. Meetings:

The Board of Directors shall meet as follows:

a. In the fall, spring, and prior to the annual meeting.

b. Additional meetings may be called at the discretion of the President.

Section 3. Duties:

The duties of the Board of Directors are to set policy, transact business of ESP, and keep the membership informed.

Section 4. Conduct Business:

The Board of Directors may conduct business by mail (postal or electronically) or some alternative process approved by the Board of Directors when necessary. A report of each action taken shall be verified and made a part of the minutes at the next Board of Directors meeting.

ARTICLE VIII – Committees and their Function

Section 1. Standing Committees:

The President will appoint members on the basis of interest and abilities to the following committees:

a. Nominating - Chaired by Immediate Past President	e. Global Relations

I. Abstracts

Section 2. Function:

These standing committees shall have the following duties. Additional duties may be assigned by the president. Other special committees, as needed, shall be appointed by the President.

a. Nominating: to prepare the yearly slate of officers.

b. Membership Recruitment and Retention: to recruit, retain and involve all ESP members and promote an effective working relationship and spirit of fraternal fellowship.

c. Public Issues: to educate and inform ESP members about public issues and legislative matters affecting Extension programs and personnel needs.

d. Resource Development and Management: to generate new ideas for resource development and management in order to maintain professional development activities; to increase funds for professional development activities.

e. Global Relations: to promote the Extension profession and professionalism worldwide.

f. Memorial: to present at the annual meeting a remembrance program of those past extension professional that have past away since the last annual meeting.

g. Member Services: to administer and provide leadership to ESP's scholarships, loans, and awards programs.

h. Audit: to audit the books at the end of the fiscal year.

i. Constitution & Bylaws: to review bylaws annually submit proposed changes to the Board of Directors for review prior to submitting to the membership; to review chapter standing Rules and Policies annually submitting changes to Board of Directors for approval; to review handbook as needed.

j. Finance: to prepare and submit proposed budget to the Board of Directors.

k. Retirees: to recruit, retain and involve retirees and promote continued involvement in ESP.

I. Abstract: to notify and encourage members to submit abstracts by the established due date. Responsibilities also include presiding and the facilitation of abstract presentations to adhere to the designated time allotment and to secure equipment requested by presenters for abstract presentations.

m. Annual Report: to solicit information and reports from the officers and the committee chairmen to compile a comprehensive annual report for distribution to the entire membership.

n. Website Management: To keep the membership up to date with all association business through routine website updates

ARTICLE IX - Meetings

Section 1. Annual Meeting:

The annual meeting of this organization shall be held during the Extension Professional Associations of Florida, Inc. conference for the purpose of furthering the objectives of the ESP, electing and installing officers, receiving reports of officers

and committees, and transacting any other business that may arise. If deemed necessary, or if the scheduled annual meeting cannot be held, the President may call a special meeting to transact business with the approval of the Board of Directors. The President shall see that a notice is sent to everyone eligible for membership telling the time and place of such a meeting.

Section 2. Special Meetings:

The President, with the approval of the Board of Directors, may call a special session of ESP and conduct business by mail (postal or electronically) or some alternative process approved by the Board of Directors as necessary.

ARTICLE X - Quorums

Section 1. Membership Quorum:

A quorum at any annual meetings shall consist of 15% of the paid membership shall be present to constitute a quorum at any called or special meeting of the membership.

Section 2. Board of Directors: A quorum of the Board of Directors shall consist of 50% of the Board of Directors

ARTICLE XI - Financing

Section 1. Membership Year: The membership year shall be from January 1st to December 31.

Section 2. Initiation Fees:

The initiation fee for ESP shall be set by the National Council. This fee shall be collected by the Alpha Delta Chapter and forwarded to the Secretary/Treasurer of the National Council, Epsilon Sigma Phi, for each member initiated. If a candidate fails to be initiated, he or she may be initiated at a subsequent meeting.

Section 3. Member Dues: Dues for the coming year are payable according to the Chapter Standing Rules and Policies.

Section 4. Payment:

Each member shall pay annual dues to the treasurer. ESP shall pay dues to the National Council of Epsilon Sigma Phi in accordance with the amount stated in the national constitution.

Section 5. Life Membership Dues:

Members, retired from the Cooperative Extension Service, may obtain a paid-up life membership by paying an amount equal to five times the National dues. Life Members have the option to pay their dues in installments over a two year period.

ARTICLE XII – Dissolution of Organization

On the dissolution of the Association, the entire net assets remaining after payment of any and all liabilities and obligations of the Association shall be transferred to such association or associations organized exclusively for charitable, educational or scientific purposes and shall at the time qualify as exempt association or associations.

ARTICLE XIII - Liability

Epsilon Sigma Phi in no way shall be liable for the acts of individual members of the Board of

Directors, nor for officers who may act beyond their authority. Officers individually or collectively shall not be liable for Epsilon Sigma Phi, unless they have acted beyond their authority as officers.

ARTICLE XIV – Non-Profit Corporation

Epsilon Sigma Phi shall conduct business like a non-profit corporation under Section 501(c)(3) of the Internal Revenue Code.

Membership

If a Past President vacancy occurs, the previous Past President may assume the position for the unexpired term. All other officer vacancies will be filled by presidential appointment, ratified by the Board of Directors.

Board Meetings

Mid-Year Board meetings will be held at a convenient time with the President determining and arranging for the meeting place.

Conference Calls

The President will schedule conference calls as needed to carry out immediate business of the Chapter. Includes the option for Board meetings when necessary.

<u>Bylaws</u>

Bylaws and Standing Rules and Policies shall be reviewed annually.

Awards

Award Nominees must be members in good standing with Dues paid by Dec 31 to the Treasurer.

Scholarships

Applicants must be members in good standing with Dues paid by December 31 and contribute to the scholarship or High 5/10 Fund.

Memorial Service at EPAF

All effort will be made to honor deceased Faculty with Extension appointments at the EPAF Conference following the death.

<u>Delegates</u>

President and President Elect will serve as delegate to all National and Regional meetings with the financial support of the chapter.
