#### **Summary of 2013-2014**

Dan Culbert, President

Dan referred everyone to the Annual Report document distributed electronically prior to the meeting, several copies of which being available in the room. Dan noted that Danielle Treadwell has a table top exhibit on the Extension Centennial Time Capsule. The deadline for submitting items for inclusion is Nov 1st.

#### Annual Meeting Minutes – August 27, 2013

Will Sheftall, Secretary

Jennifer Bearden moved acceptance of the 2013 Annual Meeting Minutes as published and distributed in the 2014 Chapter Annual Report, Robert Halman seconded. Motion to accept minutes passed unanimously.

#### Treasurer's Report & Annual Budget Proposal Lori Wiggins, Treasurer

Lori Wiggins reviewed the written Treasurer's Report. It was provided as a handout as well as having been published and distributed in the Annual Report. The report gives status of accounts (checking, savings, CDs) as of August 18, 2014. Lori noted that the income for Fiscal Year 2013-2014 was slightly higher (by \$104.16) than expenses. Alex Bolques moved to accept the Treasurer's Report, and Marjorie Moore seconded. Motion to accept was approved unanimously.

Lori reviewed the Proposed Budget for Fiscal Year 2014-2015. She noted that the new budget was developed from the budget for the previous year. The National Endowment Donation (\$403) is a pass through. Lori reported that the National ESP office is pleased that Florida passes on to the national endowment all earmarked monies that the Florida chapter receives, without taking a percentage cut (which some other state chapters do).

Lori noted that the President's expenses in 2013-14 were higher that they typically are, so that line item was reduced for 2014-15. The line for JCEP meeting expenses also was reduced. Tracy Tesdall recommended that the PILD travel amount be kept as high as traditionally budgeted. Tracy noted that she had been able to offset some of her travel costs from other sources, but that a similar situation could not be projected for different officers in 2014-15. Lori said that the budget is a target and not a firm ceiling; as long as the chapter has the money, the actual and necessary travel expenditures can be approved.

Tracy moved that we increase the JCEP allocation to \$700 (from \$600) and offset that budget adjustment by increasing the high five income by \$100 (from \$150 to \$250). Stephanie Toelle seconded the motion. Motion carried unanimously.

Mike Davis moved, and Robert Halman then seconded acceptance of the proposed and amended budget.

#### National ESP Report

#### **Jeff Myers, National ESP President**

Jeff Myers gave some highlights from the national perspective. He noted that as far as ESP goes, it is critical what we do as a local chapter. National officers and Board are there to support us. Our mission is to serve the Extension system and serve the Extension professional. Without the system, we don't exist and we don't serve a purpose. What we do to strengthen a chapter is what we do when nobody else is looking. Squeezing in time for the chapter is not easy, but important. Jeff applauded the strength of Florida's chapter.

The National ESP Board is currently working on the next strategic plan, to be approved in 2015 (at the ESP National conference in Coeur d-Ilene, ID. The effort began with ESP's strategic planning effort at Galaxy IV, and will be continued at the Board's mid-year meeting in New Orleans, LA. The Board is looking for input. Give it to Jane Gault (outgoing Southern Regional Vice President) or Dan Culbert (incoming Southern Regional Vice President) or Jeff. It is critical for the Board to hear from as many people as possible.

Jeff talked about "changing the financial pieces." He began by musing about whether we are we at a point in ESP that we don't need to have the honorary piece, and could remove the criterion of how many years a new member has worked for Extension. He noted that if we look at the workplace, there are employees coming in mid-career who don't want to wait to be part of ESP. Leadership skills, communication, listening, etc., are the soft skills that are more important than expertise. These skills are the professional development focus of ESP. Soft skills are portable for those who don't make a long career of Extension. The decision will always be left to the chapter, however.

The National Board is a great group of positive colleagues. There are six national committees. Every spring they are advertised. Volunteering to serve on a national committee is a great opportunity to grow in your professional journey.

Each year there's about \$17,000 available from national ESP in grants, scholarships and stipends. National has not been getting many applicants for the CED, DED administrative scholarship to attend the National ESP conference if you've never been before. There are \$1000 professional development grants available. The Angus Scholarship (\$500) can be used to go to the National conference – or any professional development. PILD scholarships are very competitive; 4 are generally given out each year. Two

award amounts have changed. \$300 is available to each chapter for a member to attend PILD; that award has changed to \$500/chapter. The \$200 award to attend the ESP National meeting has changed to the actual registration cost for the national conference.

The recognition program has changed over the past couple of years. Take time to nominate colleagues. Our chapter has racked up \$13,264 given to the national endowment (4th highest chapter). Florida has received \$15,000 back from this program – about the same amount as contributed.

The national meeting this year is in Indianapolis in October. Next year the national meeting will be October 5-8, 2015 in ID. Then Atlantic City in October 2016. The National Board is looking for bids from southern chapters for October 2017. Chapters typically make \$10,000 from hosting a national meeting, and the process of hosting helps build membership and chapter strength.

#### **Committee Reports**

#### Abstracts / Professional Development Stephanie Toelle, Chair

Stephanie referred everyone to page 19 in the Annual Report. There were 23 abstracts submitted; 17 were accepted. She secured funding to bring Jeff Myers to this meeting for the week and to give an IST.

#### Annual Report Andy Toelle, Chair

Andy cautioned that the Report contains what was sent to him. If there are mistakes, they need to be brought to Andy's attention via e-mail next week, with the fix needed, and he will include the fix in the FINAL report. After next week, he will not be able to accept corrections.

#### Audit Jane Corless, Chair

Jane had previously reported to the Board that everything checked out to be fine.

#### Constitution and Bylaws Brent Broaddus, Chair

Brent Broaddus introduced the proposed Bylaw and Standing Rule changes that were adopted by the Board for distribution to the membership and placement on today's agenda for voting. There was a motion by Debbie Nistler to accept the proposed revisions to Standing Rules and Bylaws. The motion was seconded by Gene McAvoy. An amendment motion was offered by Stephanie Toelle, and seconded by Juanita Popenoe. Discussion clarified that Stephanie had confused a previous version with the most recent, Board-adopted version of proposed changes, and the amendment was withdrawn. The original motion carried unanimously. Changes to the Bylaws and Standing Rules were adopted as proposed, and as follows:

#### By Laws Changes:

- Article VIII Committees, Section 1, ADD new Standing Committee ["o. Professional Development"]
- Article VIII Committees, Section 2, revised purpose of d. RDM committee: ["to generate new ideas for resource development and management in order to maintain, create or enhance professional development activities; to explore opportunities for and obtain new financial resources for professional development activities."]
- Article VIII Committees, Section 2, f. Memorial edited text ["passed away"].
- Article VIII Committees, Section 2, o. Function of Professional Development committee: ["To promote
  professional excellence, personal development and leadership development among Extension personnel. Design
  and implement additional professional development opportunities. Promote and foster professional improvement
  through collaboration with professional organizations to which Extension personnel belong. Provide leadership for
  mentoring activities conducted through Epsilon Sigma Phi.'].

New Article XV - Amendments ["These Bylaws may be amended at any annual or special meeting by a two-thirds
vote of the members present providing members were notified of suggested changes thirty days prior to the
meeting."]

#### **Standing Rule Changes:**

- New rule 1: [Standing rules may be adopted at the annual ESP Alpha Delta Chapter membership meeting by a
  majority vote of the voting delegates present and voting. Standing rules may be amended or rescinded by a twothirds vote without previous notice or a majority vote after previous notice. Standing rules may be suspended
  temporarily by a majority vote. Standing rules will be formally reviewed every other year (even-numbered years)
  by the ESP Alpha Delta Chapter Board. ]
- Change in Rule 3, : [Terms of Office
  - The Treasurer shall be appointed annually by the President with the ratification of the membership, with the option of re-appointment. All other officers are elected annually.
  - District Directors will be elected according to the following schedule:
    - Even numbered years: Northwest, Central, South, and Life Member Director.
    - Odd numbered years: Northeast, South Central, and State Specialist Director.
- Add Rule 7. Annual Budget [The voting delegates at the annual ESP Alpha Delta Chapter membership meeting shall adopt the budget for the forthcoming year.

#### **Global Relations**

#### Basil Bactawar, Chair

Basil referred members to his Committee's report in the Annual Report. Committee member Norma Samuels talked about international activities. She is putting a proposal together for the Dean on how we can engage county faculty through a workshop on internationalizing Extension. She encouraged everyone to fill out the survey on international Extension activities, push our pins into the map at the table-top exhibit, and put our business card in the basket. Teresa Olczyk talked about receiving international visitors – 100's in Miami-Dade County over the years – and that these types of activities also qualify as "international activities." Dan Culbert noted that Norma sits on the National ESP International Relations Committee.

#### Member Services (Awards)

Alejandro Bolques. FAMU/CAFS Cooperative Extension Program Faculty at First International Congress of Tropical Gardens

The 1st International Congress of Tropical Gardens was held on May 7-9, 2015 in Medellin, Columbia. The invited conference guest speakers included Brazil, Venezuela, and the United States including Columbian nationalist from Medellin and Bogota. Conference topic presentations centered on urban planning and development in the areas of sustainability, urbanization, botanical gardens, and landscape maintenance. Dr. Alex Bolques, FAMU/CAFS/Cooperative Extension Program delivered a 4-hour workshop on Rain Gardens and Water Gardens in the landscape.



Approximately 200 attended the 1st International Congress of Tropical Gardens in Medellin, Columbia. The event was coordinated by Mr. Juan Carlos to help develop capacity of urban planners, landscape architects, designers, and maintenance professionals. Workshops on uses of native plants with ornamental value in the landscape, rain gardens to reduce the effects of storm water pollution, and water gardens in the landscape provided detailed information on selection and use considerations.

- Norma Samuel attended the Caribbean Agricultural Extension Providers' Network (CAEPNet) planning meeting in Trinidad organized by the University of the West Indies in July 2015. A strategic plan for the organization was developed for 2016 2020. Norma was selected as one of two co-chairs for CAEPNet.
- Basil Bactawar attended a planning meeting in Trinidad organized by the University of the West Indies in July2015. They participated in the development of a strategic plan the Caribbean Professional Extension Network. (CAPE net).   Rutgers University is working up plans for our 2016 Conference in Cape May New Jersey.
- My role as Southern VP was to encourage bids for the 2017 Conference that comes back to the South. For the first time I may
  years, there was competition to host the ESP Conference. While there was some consideration from Florida and Oklahoma,
  two well supported bids were received from the Alpha Beta Chapter in Georgia and the Xi Chapter in North Carolina. The Board
  decided to continue down the Atlantic Coast in 2017 with our October meeting in Wilmington, North Carolina.
- As I transition to Life membership this year, I have not been able to address some of my goals of engaging our southern chapters as often as planned. I do want to shout out to Jonel Bosques and Xiomara Diaz – now at TAMU – for their assistance in reaching out to the University of Puerto Rico to reestablish the Alpha Alpha Alpha Chapter of ESP.
- I have thoroughly enjoyed my term of office this past year and look forward to another year of service to the profession. Do
  know that next spring the Southern Region will be electing two new ESP leaders next year: a new Regional Vice President for
  a two year term of service. And, the next Second Vice President will also be elected from the South. Serving on the National
  Board in either capacity is one of the most rewarding professional experiences in your career; feel free to ask me more if you or
  someone you know would be a good candidate.

The **JCEP Leadership Conference** was held during early February in Las Vegas, with our chapter being represented by Tracy Tesdall and Will Sheftall. On the agenda were many workshops and seminars from Extension colleagues from across the county. Consider applying for one of the presenter slots: those accepted will receives financial support from JCEP to attend. And, don't forget that similar opportunities to **present seminars or posters** also exist at the JCEP **PILD** conference as well as future National ESP Conferences.

#### **Scholarship Grants & Recognition Committee**

- The SGR committee met several times throughout the year via conference call to review and recommend applicants for four different Scholarship opportunities. Committee recommendations are then forwarded to the National Board for their approval
  - PILD Conference Scholarships applications were received from 7 ESP members; were awarded to members from
    Oregon, Tennessee, Georgia, Kansas, and Pennsylvania. Normally four are provided; but funds were found for a fifth
    award this year.
  - Angus Scholarships can be used for any kind of professional development project that ESP members wish to
    pursue. One applicant went to an Urban Extension Conference, while 3 other applicants selected (WY, WI and FL)
    attending the National ESP Conference in Idaho, including your incoming Chapter President Will Sheftall.
  - o Former Southern Regional VP and ESP Life member Mike McKinney provided funding several years ago to support work in the Pubic Issues arena. This year the 8th and final *McKinney Scholarship* was awarded to Doug Keenan of Indiana. Mike came to the Sunshine State from Indiana many years ago. I was thrilled to make this announcement and recognize Mike's contribution to a group of retired Indiana Extension workers that get together each winter here in Sebring.
  - Another scholarship is provided to administrators who have never been to the ESP Conference. This year the scholarship has been renamed the *Reddinger Administrator / Leader Scholarship* in honor of former ESP

President Art Reddinger, who faithfully carves the ESP Key plaque each year for the National ESP President – which is auctioned off to raise more funds for professional development. This year's scholarship recipients are from Idaho, lowa and Oregon; plus an additional fourth award to an administrator from South Carolina State University in lieu of the new 1890 scholarship.

- The Committee was asked to select recipients for a new 1890 Scholarship for Extension professionals that work primarily with
  the 1890 Land Grant Institutions. It was established to encourage a greater level of participation among 1890 Land Grants, and
  in celebration of the 125th Anniversary of the Second Morrill Act. I am pleased to announce that one of the recipients will be a
  new Alpha Delta ESP Member, Linda Sapp who is FAMU Coordinator for Cooperative Extension Program/Veterinary
  Technology Programs.
- National ESP also offers *Professional Development Grants* to Chapters that wish to conduct innovative projects that lead to professional development for Chapter members and other ESP members.
  - This year grants were awarded to Illinois, West Virginia, and North Carolina and for the second year in a row,
     Florida! Eleanor Foerste has asked for support for a Caribbean Study tour, to be held in the spring of 2016.
  - Last year our Chapter was awarded a grant that brought then-National President Jeff Myers to EPAF. He conducted a workshop on Life Coaching and participated in many other Chapter activities while visiting with us in Panama City. Approval of a National Officer visit by the ESP board enabled some cost-savings with Jeff's visit. They have been translated into another Professional Development workshop at this year's EPAF. Hat's off to Mary Campbell for working with the Chapter officers to achieve this project.
- Last fall the SGR Committee offered a webinar on the ESP recognition programs, hosted courtesy of Beth Claypoole from Cornell Cooperative Extension. It was directed towards Chapter leaders, especially for the various chapter Awards committee chairs, and any interested members wanting a better understanding of these member benefits. (It is archived on a Cornell website – ask me for the link.) Beth, who is our newly elected National Second Vice President for ESP, will help hosting another fall webinar on recognition programs in late 2015.
- The SGR committee also works with chapters to encourage applications for **recognition awards**. Statistics for the number of applications in 2015 show a slight drop in the number of chapters sending on any awards, but a 23% rise in the total number of applications (127) sent up. Diversity awards seem to be the area where there often no applicants. Ohio submitted candidates for all categories; Tennessee was the best in the south with 7/10 nominees.
- **Florida** is one of the states that uses the National website for its state Recognition programs. Among the applications form our chapter that were submitted for *National Recognition* on a Regional Basis, our Chaplin *Basil Bactawar* was selected by ESP chapters in the South to receive the *Early Career Award*, to be presented at this fall's Conference in Idaho.
- While States get to vote on the National winners for the various recognition programs, one category handled differently is the National Friends of Extension Award. This year the SGR committee received 13 nominations from the states, and recommended that four individuals be honored for 2015. Award balance among the regions of the country and the kinds and scope of volunteer roles are considered when the National Board makes the selection. And one of this year's winners is Florida's own Ron O'Connor from Farm Credit, who plans to travel to Cour d'Alene to personally receive his award!



**Minutes Approval of Minutes:** Minutes of the past two Board meetings (Winter – Monday March 3, 2014; and Spring – Wednesday May 28, 2014) had been circulated by the

Secretary for review.

Robert Halman moved approval of both sets of Minutes; Christine Kelly-Begazo seconded the motion. The motion passed unanimously.

For reference, Dan Cullbert had circulated his proposed 2014 Annual

Meeting Agenda to the Board prior to the meeting.

## Correspondence

- Jennifer Gillette-Kaufman has notified the Board that she will be unable to continue as Chapter Webmaster. Scott Jackson and Dan Culbert have administrator rights, and can continue to maintain the site.
- Dan Culbert reported that Linda Cook would like to step down as Life Member Director.
- As reflected in the Spring Board Meeting Minutes, South Central District Director David Shibles will step down in August at EPAF. Past-president Robert Halman is taking nominations to fill this position by election at the Annual Meeting.

**Treasurer's Report** – Lori Wiggins was unable to attend the meeting.

## **Committee Reports**

## EPAF Report - Dan Culbert & Tracy Tesdall

- ESP Board meeting Monday 1:30-3:00 pm The sense of those present was that individual communication would be adequate to tie up loose logistical ends, in light of the early departure required for some officers and directors to reach Panama City by early afternoon on Monday.
- ESP Abstract session 1 Tuesday 11:00 am-2:00 pm.
- ESP General Membership meeting Tuesday 3:30 [4:00 pm?] 5:30 pm (before DSA banquet). This portion of the Annual Meeting will cover: the Chapter Annual Report, election of officers and directors, approval of proposed revisions to the Chapter ByLaws, and other business. Dan Culbert proposed, and Robert Halman seconded, that the Chapter's Annual Meeting recognition agenda items be moved to Wed am. These items would be: induction of new members, awards and recognition; retiree life member report. There was consensus on this split of agenda items between the two portions of the Annual Meeting.
- EPAF DSA Banquet ESP is the host association.
  - We need 6 ESP ticket takers, who Dan indicated can be recruited at the conference.
  - Alex Bolques will be asked by Dan Culbert to offer a thought for the evening.
  - While most of the other aspects of the evening's events are being taken care of by others, e.g. award presenters, Dan asked for suggestions from Board members on how to make this a more memorable event. Processional music and table decorations were discussed. Dan indicated that he will check with Martha Maddox and last year's DSA chair to see if this is doable; Tracy volunteered to help with this. Christine asked if there would already be table decorations and front stage/head table decorations. It was suggested that a local landscaper might be willing to lend foliage plants for the head table/stage area. It is possible that any foliage plants ESP arranges to borrow could be used for the entire conference. Christine indicated that she would be willing to help Tracy with these aspects of the DSA banquet preparations.

This portion of our Annual Meeting will include new member induction, chapter recognition, and officer transition. Mike Davis has the new member induction ceremony taken care of. Dan suggested making the transfer in officers at this meeting. He'll also give Jeffrey Myers the opportunity to make some comments.
- ESP Abstract session 2 Wednesday 8:15-11:50 am.
- Retiree / Friends Luncheon Wednesday + EPAF Memorial Service: Alex Bolques will conduct the Memorial Service.
- ESP member Workshop: Life Coaching Wednesday 2:15–5:00 pm (concurrent with other IST sessions).
- National ESP officer visit to EPAF: Jeffrey D. Myers, National President-Elect
   Dan Culbert suggested that we consider conveying Honorary Chapter Membership on
   Jeffrey Myers. Robert Halman suggested that a non-Extension person might be the
   envisioned recipient of honorary membership, as opposed to an existing member. Will
   asked if there might be issues with dual, concurrent chapter membership. Christine
   suggested we investigate this further, since Honorary Alpha Delta Chapter membership

could be a nice honor. There was not consensus on the appropriateness of moving forward, so Dan suggested that next year's Analyst could look into this as a procedural matter.

**Constitution and Bylaws Report** – Dan Culbert (appended to these Minutes are the pertinent ByLaws and Rules sections to which changes have been proposed as annotated, as submitted by Committee Chair Brent Broaddus to President Culbert)

- Dan Culbert referenced the previously emailed Bylaw and Rule revision proposals from Brent Broaddus. Any changes the Board wishes to propose to the Membership must be approved today and then forwarded to the general membership along with the official notice of our annual meeting, no later than Sunday July 27th in order to meet the "30 days-prior" notification requirement.
- Dan Culbert reported that Brent had discovered that there is a lack of process for amending the Bylaws. Dan indicated that he has checked some archives and found that there was a Bylaw Article that outlined Amendments in 2002 (General Membership majority vote, 30 days' notice) but it seems to have disappeared by the 2009 version of our Bylaws.
- Tracy Tesdall moved to propose adoption of all Bylaws and Standing Rules changes except the revisions pertaining to the scope and definition of the Abstracts/Professional Development Committee. Robert Halman seconded her motion. Discussion ensued. LuAnn Duncan concurred with Tracy on the advisability of adding an additional committee for Professional Development, separate from Abstracts and also separate from Resource Development (which had been discussed as a previous Board meeting). The question was not called, and Tracy's motion died. Christine Kelly-begazo then moved to prose adoption of the Bylaws revisions with the change of adding a new Committee to handle Professional Development, whose scope would be defined using the same language pertaining to professional development that Brent had proposed under the section describing the Abstracts/Professional Development Committee. Linda Seals seconded Christine's motion; it passed with one 6 in favor, one opposed.
- Tracy Tesdall moved to propose adoption of the changes to Standing Rules; Robert seconded her motion. It passed with a unanimous vote.

## Nominating Committee Report – Robert Halman

- Robert reported that he is preparing a secret ballot for the meeting, since 2 names have been submitted thus far for the office of Chaplain (Basil Bactawar and LuAnne Duncan). Basil indicated he would be willing to withdraw his nomination given LuAnne's interest in the office, but he agreed to stay on the ballot.
- Thus far, Samantha Kennedy is the only nominee to succeed David Shibles as South Central Director.
- Dan Culbert pointed out that if the rotation plan described in the proposed Bylaws revision is approved, we will need to re-elect Northwest, Central, South, and Life Directors. Will suggested that the first rotational elections should logically take place at the first Annual Meeting following approval of the new Bylaws, which would be 2015, at which time the odd-year Director positions would turn over. Robert Halman concurred. There was consensus that this would be the most logical way to implement the new election schedule.

## Appendix 1 – Proposed Bylaws Changes submitted to the Board by Committee Chair Brent Broaddus:

## **ARTICLE VIII - Committees and their Function**

## Section 1. Standing Committees:

The President will appoint members on the basis of interest and abilities to the following committees:

- a. Nominating Chaired by Immediate Past President
- b. Membership Recruitment and Retention
- c. Public Issues
- d. Resource Development and Management
- e. Global Relations
- f. Memorial
- g. Member Services
- h. Audit
- i. Constitution & Bylaws
- j. Finance
- k. Retirees
- I. Professional Development
- m. Annual Report
- n. Webpage Management

## Section 2. Function:

These standing committees shall have the following duties. Additional duties may be assigned by the president. Other special committees, as needed, shall be appointed by the President.

a. Nominating: to prepare the yearly slate of officers.

- b. Membership Recruitment and Retention: to recruit, retain and involve all ESP members and promote an effective working relationship and spirit of fraternal fellowship.
- c. Public Issues: to educate and inform ESP members about public issues and legislative matters affecting Extension programs and personnel needs.
- d. Resource Development and Management: to generate new ideas for resource development and management in order to maintain, create or enhance professional development activities; to explore opportunities for and obtain new financial resources for professional development activities.
- e. Global Relations: to promote the Extension profession and professionalism worldwide.
- f. Memorial: to present at the annual meeting a remembrance program of those past extension professional that have passed away since the last annual meeting.
- g. Member Services: to administer and provide leadership to ESP's scholarships, loans, and awards programs.
- h. Audit: to audit the books at the end of the fiscal year.
- i. Constitution & Bylaws: to review bylaws annually submit proposed changes to the Board of Directors for review prior to submitting to the membership; to review chapter standing Rules and Policies annually submitting changes to Board of Directors for approval; to review handbook as needed.
- j. Finance: to prepare and submit proposed budget to the Board of Directors.
- k. Retirees: to recruit, retain and involve retirees and promote continued involvement in ESP.
- I. Professional Development: To promote professional excellence, personal development and leadership development among Extension personnel. Solicit proposals for concurrent session, poster and ESP committee sponsored presentations. Evaluate and recommend concurrent session and poster session proposals and notify applicants. Design and implement additional professional development opportunities. Promote and foster professional improvement through collaboration with professional organizations to which Extension personnel belong. Provide leadership for mentoring activities conducted through Epsilon Sigma Phi.
  - m. Annual Report: to solicit information and reports from the officers and the committee chairmen to compile a comprehensive annual report for distribution to the entire membership.
  - n. Website Management: To keep the membership up to date with all association business through routine website updates

## **ARTICLE XV - Amendments**

These Bylaws may be amended at any annual or special meeting by a two-thirds vote of the members present providing members were notified of suggested changes thirty days prior to the meeting.

## Appendix 2 – Proposed Standing Rules Changes submitted to the Board by Committee Chair Brent Broaddus:

Standing rules may be adopted at the annual ESP Alpha Delta Chapter membership meeting by a majority vote of the voting delegates present and voting. Standing rules may be amended or rescinded by a two-thirds vote without previous notice or a majority vote after previous notice. Standing rules may be suspended temporarily by a majority vote. Standing rules will be formally reviewed every other year (even-numbered years) by the ESP Alpha Delta Chapter Board.

## 2. Officer Nominations and Elections Process

Election of officers is held at the annual membership meeting.

## Terms of Office

- The Treasurer shall be appointed annually by the President with the ratification of the membership with the option of re-appointment. All other officers are elected annually.
- District Directors will be elected according to the following schedule:
  - Even numbered years: Northwest, Central, South, and Life Member Director
  - Odd numbered years: Northeast, South Central, and State Specialist Director.

## 3. Annual Budget

Want to be combined with another workshop on Wellness. Will be a total of 4 hours of In-Service Training. There will be a minimum of 10 people needed to sign up for the IST. Christopher Jones will be presenting. He is a County Agent in Arizona (Ag. & Nat. Res.). Need a budget discussion to determine if the Chapter will be able to cover some expenses along with funding from the Dean. The national ESP **election of officers** for 2015-16 was recently completed; the following are the results:

- ESP National 2nd Vice President 4 year term from the Northeast Region: Elizabeth
   Claypoole New York / Lambda Chapter
- Northeast Region Vice President 2 year term: Beth Raney Pennsylvania / Alpha Omicron Chapter
- Western Region Vice President 2 year term: Rusty Collins Colorado / Zeta Chapter

These new officers will be installed at the National meeting in October.

I would note that *next year* the Southern Region will be selecting a Regional VP to take over the position I now hold for the next 2-year term; and, a National Second VP from the South will enter the rotation for a 4-year term of office.

At the Board's Mid-year meeting in New Orleans, significant progress on the **National ESP Strategic Plan** was made. The plan will be a three year (rather than a 5-year) plan in order that there is some personal continuity among the officers. The plan helps our committees establish annual goals and objectives. The Plan will be approved at the 2015 National meeting in Idaho.

- Florida's **Friend of Extension** nominee, *Ron O'Conner* of Farm Credit has been selected for National ESP recognition. The Alpha Delta Chapter will be asked to help underwrite his expenses for attend the Awards' program in Idaho.
- Eleanor Foerste submitted a proposal for a Professional Development Grant for an International Study Program grant for net spring; happy to say that it was funded by National ESP.
- There is one more Angus Scholarship to be awarded within the next two weeks Will Sheftall is one of the three applicants. Also there are three applications for four Reddinger Administrator Scholarships none has been submitted by Alpha Delta the deadline to apply has been moved to June 15.
- I would note that whoever is going to PILD next year should apply for a PILD scholarship if they have not been to this conference before.

As a **summary of the Awards programs**, the Southern region had submitted applications for all categories of recognition this year, except for the Ruby award. # ALPHA DELTA CHAPTER CONSITITUTION

#### Article I - Name

The name of this organization shall be the Alpha Delta Chapter, Epsilon Sigma Phi, National Extension Fraternity.

## Article II - Purpose

## Section A

The purpose of this association shall be exclusively charitable and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

#### Section B

This purpose includes, but is not limited to:

- 1. maintaining the standards and ideals, preserving the traditions and upholding the morale, prestige and respect of the Cooperative Extension Service; and,
- 2. developing an effective working relationship and a spirit of fraternal fellowship among the present and past employees of the Cooperative Extension Service.

## Article III - Membership

## Section A

## Qualifications:

- 1. duly elected faculty, professional and administrative staff who have held full or part-time Extension appointments for a total of three or more years (the three-year requirement does not apply to ESP members in other states transferring to Florida); and,
- 2. have displayed a cooperative and helpful attitude toward fellow Extension employees, demonstrated competency in assigned fields of responsibility; and,
- 3. exhibited ability in educational techniques essential to the conduct of an effective Extension program.

## Section B

## Classification:

- 1. Active: Active members are those who are engaged in professional Extension work and who have met all qualifications of membership;
- 2. Life: Active Alpha Delta Chapter members may become life members upon their retirement from Extension work.

## Section C

### Election:

1. Membership shall be on the basis of a ninety percent (90%) favorable vote by the eligible voters who properly mark and cast their ballot.

## Section D

Eligible Voters - All active members.

## Section E

## Voting:

- 1. Membership voting may be taken by mail, an alternative method or at any annual or called meeting or a combination in compliance with the requirements stated below; and,
- 2. The vote shall be reported not later than at the next annual meeting of the fraternity after the membership has been proposed.
- 3. Alternative provisions for the process of the membership to cast their votes shall be adopted at the discretion of the board of directors.

## Section F

## Membership Criteria

- 1. Acceptance of membership by the newly elected member shall be acknowledged in writing and accompanied by the initiation fee, prior to the date of initiation; and,
- 2. A person may withdraw from membership by notifying the Secretary in writing; and,
- 3. Any member who fails to pay annual dues shall be dropped from membership in the fraternity and shall be so notified in writing by the Secretary; and,
- 4. Any member may be expelled from the fraternity for failure to observe the obligation or for conduct unbecoming a member of the fraternity; and,

- 5. Charges may be referred in writing, signed by two members; and,
- 6. These charges shall be reviewed by the membership committee which will investigate the charges and report to the fraternity, making a recommendation and,
- 7. An accused member shall have right of personal hearing and to file evidence in regard to preferred charges; and,
- 8. Expulsion from the fraternity shall require that three-fourths of all eligible voters, as defined above, cast their ballots with a simple majority showing support of the motion to expel.
- 9. Reinstatement Any member whose membership has lapsed may be reinstated by paying regular dues and a reinstatement fee of \$10.00. Retirees are exempt from paying the reinstatement fee.

## **Article IV - Officers**

The officers of this organization shall consist of a President, President-Elect, Secretary, Treasurer, Annalist, Chaplain and Immediate Past President.

## Article V - Meetings and a Quorum

## Section A

An annual meeting shall be at the time of the annual Extension Professional Associations of Florida, Inc. meeting.

## Section B

Special meetings shall be held upon call of the President or upon written request of twenty percent of the members.

## Section C

A Quorum - 15% of the paid membership shall be present to constitute a quorum at any called or special meeting of the membership.

## **Article VI - Initiation Fees and Dues and Changes**

## Section A

Initiation fee - For this chapter it shall be set annually and will include state and national dues for one year.

## Section B

State and National Dues - Shall be payable to the Secretary prior to the annual chapter meeting.

## Section C

Changes - Made by the National Council in dues and/or fees will automatically apply to the local chapter.

## Article VII - Emblem and Membership Card

## Section A

The official emblem shall be that adapted by the National Council of Epsilon Sigma Phi.

## Section B

Each member will be provided with a membership card signed by the local chapter secretary and the national organization secretary.

## **Article VIII - Amendments**

This Constitution may be amended at any annual or special meeting by a two-thirds vote of the members present providing members were notified of suggested changes thirty days prior to the meeting.

#### **ARTICLE I - Name and Mission**

## **ARTICLE I - Name and Mission**

## Section 1. Name:

The name of this organization shall be Alpha Delta Chapter, Epsilon Sigma Phi, The National Honorary Extension Fraternity, herein referred to as ESP.

## Section 2. Mission:

ESP is dedicated to fostering the standards of excellence in the Extension System and developing the Extension Profession and professional.

## **ARTICLE II - Purpose**

## Section 1. Purpose:

The purpose of ESP is:

- a. to serve exclusively as a charitable and educational organization within the meaning of Section 501(c)(3) of the Internal Revenue code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).
- b. to recognize excellence in the Extension community.
- c. to provide opportunity for networking, fellowship and collaborative efforts.
- d. to foster leadership development through mentoring Extension professionals in the philosophy and professional practice of Extension education.
- e. to facilitate professional development.

## **ARTICLE III – Membership**

Epsilon Sigma Phi is an equal opportunity/affirmative action fraternity. Epsilon Sigma Phi is committed to the active involvement of all its members regardless of race, color, sex, age, religion, national origin, disability, or veteran status. Epsilon Sigma Phi values and seeks a diverse membership.

## Section 1. Qualifications:

The membership of ESP shall consist of duly installed faculty, professional and administrative staff who have held full or part-time Extension appointments for a total of three or more years on June 1, and who shall have displayed a cooperative and helpful attitude toward fellow Extension employees, demonstrated competency in assigned fields of responsibility, and exhibited ability in educational techniques essential to the conduct of an effective Extension program.

#### Section 2. Classes:

There shall be three classes of membership: A) member, B) honorary, and C) life.

- a. MEMBER. An Extension professional (currently employed by or retired from an entity of the Cooperative Extension System) has exhibited excellence in programming and leadership. Members continue to provide leadership and excellence in Extension programming throughout their career and during retirement.
- b. HONORARY. May be named upon recommendation of the ESP officers and approval by two-thirds of members present and voting at the annual meeting of the Chapter. Honorary members will not pay membership dues to the Alpha Delta Chapter. A proposal of honorary membership must be accompanied by a detailed statement showing the "meritorious service" it is proposed to recognize.
- c. LIFE MEMBERSHIP. Members who are retired from the Cooperative Extension System, may obtain a paid-up life membership by paying an amount equal to five times the National dues at the time of the purchase of paid-up life membership or may be made as installment payments over a two year period. These members hold equal rights and privileges to those paying annual dues.

## Section 3. Transfer of Membership:

Active members in good standing in another chapter of Epsilon Sigma Phi may transfer upon:

- a. making request to Alpha Delta Chapter.
- b. paying initiation fee and being initiated.
- c. paying annual dues.

## Section 4. Termination of membership:

After one year of non-payment of dues, membership in ESP will be terminated. A person can be reinstated by payment of dues plus a \$10.00 reinstatement fee. Retirees are exempt from paying the reinstatement fee.

## **ARTICLE IV - Business**

## Section 1. Fiscal Year:

The fiscal year of Alpha Delta Chapter shall begin on the first day of October and end on September 30 of the following year.

## Section 2. Meetings:

The annual meeting of the Alpha Delta Chapter shall be held in conjunction with the Extension Professional Associations of Florida, Inc. meeting. Special meetings may be called by the President or upon written request of twenty percent of the members.

## Section 3. Place of Business:

The principal place of business of the Alpha Delta Chapter, Epsilon Sigma Phi, shall be the University of Florida, Gainesville, Florida.

## ARTICLE V - Officers, Directors, and Elections

## Section 1. Officers:

The officers of ESP are: President, President-Elect, Secretary, Treasurer, Annalist, Chaplain, and Immediate Past President.

#### Section 2. Directors:

The directors are: one from each Extension administrative district, one from state faculty, and one from life members/retirees.

## Section 3. Terms of Office:

The Treasurer shall be appointed annually by the President with the ratification of the membership with the option of re-appointment. All other officers are elected annually. District Directors serve a two-year term with half elected each year, according to the standing rules.

### Section 4. Election:

The nominating committee shall present a slate of officers at the annual business meeting. ESP members present will vote, with election by majority vote.

## Section 5. Assumption of Duties:

The officers and directors will assume their duties upon adjournment of the annual meeting at which they are elected. In the event of no annual meeting, the officers and directors will assume their duties at the conclusion of the election by mail (postal or electronically) or some alternative process approved by the Board of Directors.

## Section 6. Filling Vacancies:

If a vacancy occurs in the President's position, the President-Elect will automatically assume the Presidency for the unexpired term and then serve another full term as President. The President-Elect's position would remain vacant until the next annual meeting.

If a Past President vacancy occurs, the previous Past President may assume the position for the unexpired term.

All other officer and director vacancies will be filled by presidential appointment, ratified by the Board of Directors.

## **ARTICLE VI – Functions of Officers and Directors**

## Section 1. President:

The President shall preside at all ESP meetings. The President shall appoint all chairs and committee members necessary to carry out the business of ESP.

## Section 2. President-Elect:

The President-Elect shall assume the duties of the President in his/her absence. The President-Elect shall appoint a Co-chair of each standing committee, who will become the chair the following year.

## Section 3. Secretary:

The Secretary shall keep accurate records of honorary members and all meetings of the Executive Board and annual business meeting.

#### Section 4. Treasurer:

The Treasurer shall keep the official record of all membership and an accurate record of all monies. He/she shall also serve as chair and liaison between the Finance Committee and the Board of Directors.

#### Section 5. Annalist:

The Annalist shall serve as Chair of the Membership Recruitment and Retention Committee. He/she shall be responsible for keeping updated biographical information on each member.

#### Section 6. Chaplain:

The Chaplain shall have official charge of all religious and memorial services.

## Section 7. Directors:

Directors will represent the area in which they serve, attend Board meetings, and encourage membership and participation of members.

## Section 8. Immediate Past President:

The Immediate Past President shall give counsel to the Board of Directors, chairs nominating committee.

## **ARTICLE VII - Board Of Directors**

## Section 1. Members:

The Board of Directors shall consist of fourteen (14) members.

- a. Officers (6) President, President-Elect, Secretary, Treasurer, Annalist, Chaplain
- b. The immediate Past President
- c. The seven (7) directors (5 Extension Districts, 1 state faculty, 1 retiree)

## Section 2. Meetings:

The Board of Directors shall meet as follows:

- a. In the fall, spring, and prior to the annual meeting.
- b. Additional meetings may be called at the discretion of the President.

#### Section 3. Duties:

The duties of the Board of Directors are to set policy, transact business of ESP, and keep the membership informed.

## Section 4. Conduct Business:

The Board of Directors may conduct business by mail (postal or electronically) or some alternative process approved by the Board of Directors when necessary. A report of each action taken shall be verified and made a part of the minutes at the next Board of Directors meeting.

## **ARTICLE VIII - Committees and their Function**

## Section 1. Standing Committees:

The President will appoint members on the basis of interest and abilities to the following committees:

- a. Nominating Chaired by Immediate Past President
- b. Membership Recruitment and Retention
- c. Public Issues
- d. Resource Development and Management
- e. Global Relations
- f. Memorial
- g. Member Services
- h. Audit
- i. Constitution & Bylaws
- j. Finance
- k. Retirees
- I. Abstracts
- m. Annual Report
- n. Webpage Management

## Section 2. Function:

These standing committees shall have the following duties. Additional duties may be assigned by the president. Other special committees, as needed, shall be appointed by the President.

- a. Nominating: to prepare the yearly slate of officers.
- b. Membership Recruitment and Retention: to recruit, retain and involve all ESP members and promote an effective working relationship and spirit of fraternal fellowship.

- c. Public Issues: to educate and inform ESP members about public issues and legislative matters affecting Extension programs and personnel needs.
- d. Resource Development and Management: to generate new ideas for resource development and management in order to maintain professional development activities; to increase funds for professional development activities.
- e. Global Relations: to promote the Extension profession and professionalism worldwide.
- f. Memorial: to present at the annual meeting a remembrance program of those past extension professional that have past away since the last annual meeting.
- g. Member Services: to administer and provide leadership to ESP's scholarships, loans, and awards programs.
- h. Audit: to audit the books at the end of the fiscal year.
- i. Constitution & Bylaws: to review bylaws annually submit proposed changes to the Board of Directors for review prior to submitting to the membership; to review chapter standing Rules and Policies annually submitting changes to Board of Directors for approval; to review handbook as needed.
- j. Finance: to prepare and submit proposed budget to the Board of Directors.
- k. Retirees: to recruit, retain and involve retirees and promote continued involvement in ESP.
- I. Abstract: to notify and encourage members to submit abstracts by the established due date. Responsibilities also include presiding and the facilitation of abstract presentations to adhere to the designated time allotment and to secure equipment requested by presenters for abstract presentations.
- m. Annual Report: to solicit information and reports from the officers and the committee chairmen to compile a comprehensive annual report for distribution to the entire membership.
- n. Website Management: To keep the membership up to date with all association business through routine website updates

## **ARTICLE IX - Meetings**

## Section 1. Annual Meeting:

The annual meeting of this organization shall be held during the Extension Professional Associations of Florida, Inc. conference for the purpose of furthering the objectives of the ESP, electing and installing officers, receiving reports of officers and committees, and transacting any other business that may arise. If deemed necessary, or if the scheduled annual meeting cannot be held, the President may call a special meeting to transact business with the approval of the Board of Directors. The President shall see that a notice is sent to everyone eligible for membership telling the time and place of such a meeting.

## Section 2. Special Meetings:

The President, with the approval of the Board of Directors, may call a special session of ESP and conduct business by mail (postal or electronically) or some alternative process approved by the Board of Directors as necessary.

#### **ARTICLE X - Quorums**

## Section 1. Membership Quorum:

A quorum at any annual meetings shall consist of 15% of the paid membership shall be present to constitute a quorum at any called or special meeting of the membership.

#### Section 2. Board of Directors:

A quorum of the Board of Directors shall consist of 50% of the Board of Directors

## **ARTICLE XI - Financing**

## Section 1. Membership Year:

The membership year shall be from January 1st to December 31.

#### Section 2. Initiation Fees:

The initiation fee for ESP shall be set by the National Council. This fee shall be collected by the Alpha Delta Chapter and forwarded to the Secretary/Treasurer of the National Council, Epsilon Sigma Phi, for each member initiated. If a candidate fails to be initiated, he or she may be initiated at a subsequent meeting.

## Section 3. Member Dues:

Dues for the coming year are payable according to the Chapter Standing Rules and Policies.

## Section 4. Payment:

Each member shall pay annual dues to the treasurer. ESP shall pay dues to the National Council of Epsilon Sigma Phi in accordance with the amount stated in the national constitution.

## Section 5. Life Membership Dues:

Members, retired from the Cooperative Extension Service, may obtain a paid-up life membership by paying an amount equal to five times the National dues. Life Members have the option to pay their dues in installments over a two year period.

## **ARTICLE XII – Dissolution of Organization**

On the dissolution of the Association, the entire net assets remaining after payment of any and all liabilities and obligations of the Association shall be transferred to such association or associations organized exclusively for charitable, educational or scientific purposes and shall at the time qualify as exempt association or associations.

## **ARTICLE XIII - Liability**

Epsilon Sigma Phi in no way shall be liable for the acts of individual members of the Board of Directors, nor for officers who may act beyond their authority. Officers individually or collectively shall not be liable for Epsilon Sigma Phi, unless they have acted beyond their authority as officers.

## **ARTICLE XIV – Non-Profit Corporation**

Epsilon Sigma Phi shall conduct business like a non-profit corporation under Section 501(c)(3) of the Internal Revenue Code.

#### Bylaws

Bylaws and Standing Rules and Policies shall be reviewed annually.

#### Awards

Award Nominees must be members in good standing with Dues paid by Dec 31 to the Treasurer.

## **Scholarships**

Applicants must be members in good standing with Dues paid by December 31 and contribute to the scholarship or High 5/10 Fund.

## Memorial Service at EPAF

All effort will be made to honor deceased Faculty with Extension appointments at the EPAF Conference following the death.

## Delegates

President and President Elect will serve as delegate to all National and Regional meetings with the financial support of the chapter.
