## President's Report

Dear Fellow Members of Alpha Delta Chapter:

It has been a good year. As "keepers of Extension's culture," ESP continues to inspire successive generations of Extension educators to uphold our respected heritage of high ideals, service above self, and best practices – by aspiring to a rewarding career in Extension, not just a job. Thank you for your dedication to fostering leadership development and mentoring within the Extension profession. You do it through your membership and active involvement in ESP, and through peer leadership and mentoring in your office or unit, week in and week out.

Florida Extension is absorbing a wave of career agent and specialist retirements. Replacing us baby-boomers are bright and eager Millennials. They are the kids our retiring generation raised, now in the vanguard leading us into a technological future. Mentor them well. Ensuring their acclimation to Extension's culture is among the most important ways that we as ESP members can proactively promote our profession, and secure Extension's legacy.

We had a real highlight this year: Florida's Ron O'Connor was one of four national "Friends of Extension" who made the trek to Coeur d'Alene, Idaho, to be recognized at the 2015 ESP Conference! Ron had been nominated by Martha Maddox and recognized in Florida as our chapter's "Friend of Extension" in 2014. Ron has personified and exemplified Farm Credit's partnership with Extension in Florida for many years. Continue to nominate worthy partners and supporters of Extension. This year, regrettably, we have no "Friend of ESP" to recognize at EPAF.

Florida continues to provide leaders for ESP at the national level. Dan Culbert served his final year as our Southern Regional Vice-president and Chair of the Scholarships, Grants and Recognition Committee. Three Alpha Delta members are involved with National ESP Committees: Norma Samuels with Global Relations; Mary Keith with Marketing; and beginning in October, Dan Culbert with Professional Development. These are official appointments. The process begins with self-nomination, though, through the ESP National Web site. Consider it!

A treat is in store: Incoming Southern Regional Vice-president Jennifer Grogan of Southwest Georgia will be our chapter's guest for the 2016 Annual Membership Meeting at EPAF. Mike Davis looks forward to hosting Jennifer's visit with us, and giving our 2016-17 officers a chance to get to know her. I've met Jennifer at national meetings, and am pleased that such a dynamic, knowledgeable and dedicated colleague will be filling Dan's big shoes as the national officer who Alpha Delta can rely on to keep us upto-date on ESP opportunities and deadlines.

Down in the weeds on the home front, I'm pleased that this year saw several noteworthy milestones that aren't sparkly, but should strengthen our chapter long-term. Chief among them from my perspective as your President:

- Re-institution of our chapter's Finance Committee with Standing Rules definition of its membership and operational guidelines, proposed for voting at the Annual Membership Meeting;
- Establishment of a new scholarship for non-officer participation in JCEP's annual Leadership Conference:
- Clear budgetary support for officer participation in ESP's annual national meeting and conference;
   and
- Establishment of a new precedent that ESP's two representatives to Florida's PILD delegation should be members of the Public Issues Committee not currently in the officer rotation.

There are common threads that run through these administrative adjustments: Broadening the base of members involved in chapter leadership at the state and national level; and promoting greater familiarity of Alpha Delta Chapter leaders with National ESP programs that can benefit our members.

Speaking of strengthening our chapter by increasing the breadth of members involved in its leadership, I think my most important contribution over five years in the officer rotation may not be anything I have done, in spite of conscientious attempts to meet the responsibilities of Chaplain, Analyst, Secretary, President-elect and President.

Several months ago I was musing about what I would say as your out-going president, about what I was proud to have contributed to ESP during my term. I thought back to the phone call I got from John Lilly five years ago, pleading with me to accept his nomination for ESP Chaplain, because everyone else he'd asked had turned him down! John and I had worked together for years hosting and teaching a bi-county 4-H Wildlife Camp. I couldn't refuse to help out a pleading colleague, even knowing the work I was signing up for. So now five years on, I was wondering to myself whether I had exceeded expectations, or confirmed the wisdom of being a Hail Mary pick.

In the middle of these thoughts came a revelation: It had not dawned on me for four and a half years that I was the first former FANREP officer to go through the ESP officer rotation. Ten years after FANREP's establishment as a constituent member of EPAF, the second person to serve FANREP as president was asked to stand for election to Alpha Delta Chapter's leadership rotation. Fifteen years after FANREP's establishment, a former FANREP and ANREP officer has served ESP as chapter president for the first time – a milestone worth noting.

I now see in hindsight that perhaps my most significant contribution to ESP has been bringing other seasoned FANREP and ANREP officers into ESP leadership roles. Not consciously, mind you, but because it's human nature to reach out to those with whom we've worked – in our disciplines and associations, and in some cases across disciplinary lines in our districts when we've worked together as John Lilly and I had, before that call.

As educators, we know role models are key to full participation. Perhaps my being in the officer rotation has made it possible for current and former FANREP and ANREP officers to "see" themselves in ESP leadership roles, and get to "Yes!" I think our chapter has benefitted from the seasoned leadership of Becky Jordi, Lara Milligan, Maia McGuire and Ramona Madhosingh-Hector chairing committees this year. I thank

them for accepting my challenge to add an "ESP phase" to the FANREP and ANREP leadership they have provided over careers of distinction.

What's hugely important is that ESP is breaking out of a rut; for all practical purposes, we'd been stuck with the task of trying to fill committee and officer slots from only 75% of our four sister associations! Our robustness, resilience and relevance are strengthened when colleagues across *all* disciplines and associations join together in ESP chapter work. I hope my legacy is that successors in the officer rotation will mindfully nominate former and current FANEP leaders to elective office, and they in turn will recruit NR and FSG colleagues to chair committees.

Finally, I want to thank all of our officers and committee chairs, whose support and diligent execution of their respective duties have made it possible for me to serve you with some measure of competence this year. Dan Culbert has been a champion of keeping us connected with National ESP, and Mike Davis has been the ever-dependable, ever-ready right-hand man. The chapter will be in good hands this coming year. Mike and the slate of capable rotational officers and directors, assisted by Jennifer Grogan, will do a fine job. Please step up to help!

# Epsilon Sigma Phi Alpha Delta Chapter STANDING RULES AND POLICIES

Standing rules may be adopted at the annual ESP Alpha Delta Chapter membership meeting by a majority vote of the voting delegates present and voting. Standing rules may be amended or rescinded by a two-thirds vote without previous notice or a majority vote after previous notice. Standing rules may be suspended temporarily by a majority vote. Standing rules will be formally reviewed every other year (even-numbered years) by the ESP Alpha Delta Chapter Board.

### 1. Membership

Dues: annual dues are delinquent December 31 of each year.

Dues amounts: Renewing members \$60.00, new members \$70.00 (includes initiation fees), life membership (five times annual national dues) \$200.00. A former member can be reinstated by payment of dues plus \$10.00 reinstatement fee. Retirees are exempt from paying the reinstatement fee.

Dues: Cannot be refunded, but may be transferred where applicable.

#### 2. Officer Nominations and Elections Process

Election of officers is held at the annual membership meeting.

#### **Terms of Office**

- The Treasurer shall be appointed annually by the President with the ratification of the membership with the option of re-appointment. All other officers are elected annually.
- District Directors will be elected according to the following schedule:
  - Even numbered years: Northwest, Central, South, and Life Member Director.
  - Odd numbered years: Northeast, South Central, and State Specialist Director.

#### Filling Vacancies

If a vacancy occurs in the President's position, the President-Elect will automatically assume the Presidency for the unexpired term and then serve another full term as

President. The President-Elect's position would remain vacant until the next annual meeting.

If a Past President vacancy occurs, the previous Past President may assume the position for the unexpired term.

All other officer vacancies will be filled by presidential appointment, ratified by the Board of Directors.

### 3. **Board Meetings**

Mid-Year Board meetings will be held at a convenient time with the President determining and arranging for the meeting place.

#### 4. Conference Calls

The President will schedule conference calls as needed to carry out immediate business of the Chapter. Includes the option for Board meetings when necessary.

### 5. Bylaws

Bylaws and Standing Rules and Policies shall be reviewed annually.

## 6. Annual Budget

The voting delegates at the annual ESP Alpha Delta Chapter membership meeting shall adopt the budget for the forthcoming year.

## 7. Awards

Award Nominees must be members in good standing with Dues paid by Dec 31 to the Treasurer.

## 8. Scholarships

Applicants must be members in good standing with Dues paid by December 31 and contribute to the scholarship or High 5/10 Fund.

## 9. Memorial Service at EPAF

All effort will be made to honor deceased Faculty with Extension appointments at the EPAF

Conference following the death.

#### 10. Delegates

President and President Elect or their designee will serve as delegate to all National and Regional meetings with the financial support of the chapter.

## 11. Membership Committees (Membership & Operating Details)

#### a. Finance Committee

Under the Bylaws, the chapter's Finance Committee is a Standing Committee chaired by the elected Treasurer, and comprised of members recruited and appointed by the President.

The Finance Committee's *annual membership* is hereby further defined to include, by office:

- The current chapter President;
- The current chapter President-elect; and
- The current Chair of the Resource Management (Foundation) Committee.

In addition, the President, with the advice and consent of the Treasurer, annually shall appoint or reappoint to the Finance Committee:

- One member-at-large not currently holding an elected office in the chapter's officer rotation (but could be serving currently as a District Director), who has served previously as Treasurer of a sister association at either the state and/or national level; plus
- 1-2 additional members-at-large who are interested in chapter finances and may have an interest in standing for election to the office of chapter Treasurer in a future year.

The Finance Committee's *annual operating program* is hereby further defined to include:

- Annual solicitation of Committee budget requests linked to Committee proposals for new and existing programs of value to the membership;
- Annual preparation of a draft proposed budget, to be submitted to the Board for discussion and revision at the Summer Board Meeting, prior to presentation to the general membership for adoption at the Annual Membership Meeting;
- Consultation on financial management decisions the Treasurer must make;
- At the request of the chapter Board, development of financial scenarios for chapter funds if new initiatives or programs under discussion were to be adopted and funded.

- 1. Abstracts were made available to the committee on April 28 and reviews were requested by May 18, 2016.
- 2. The committee reviewed 15 abstracts, and 14 were given scores high enough to be accepted for presentation at the abstract sessions at the 2016 EPAF Conference. All abstracts were scored by four reviewers, as requested by the EPAF Abstract Co-Chairs.

Thank you for the 2015-2016 scholarship. I used the funds to offset registration and lodging costs association with enrollment and certification in the "CAPS" training held in West Palm, FL, December 2 – 4, 2015.

"CAPS," Certified Aging in Place Specialist training, a designation program offered since 2002 jointly by AARP and the National Home Builders Association, was taught by a licensed member of the National Home Builders Association.

The certification training was composed of three CAPS courses each costing \$300. They were:

CAPS I: Marketing & Communication Strategies for Aging & Accessibility

CAPS II: Design/Build Solutions for Aging and Accessibility CAPS III: Business Management for Building Professionals

As a healthy homes/housing Extension educator, this certification increased my knowledge and credentials in the field of home safety and design to market awareness and provide education to help families to remain safely and comfortably in their homes as they age.

ESP Scholarship Report 2015-16 LuAnn Duncan

Iowa State Sausage School November 2015

Sessions were offered on pork, basic meat science, non meat sausage ingredients, and how to make fresh sausage. We learned about spices and flavorings, preservatives, and types of casings. We toured the lowa State Meat laboratory. Commercial sausage information on meat emulsions, sausage clips, stuffing and thermal processing were addressed. The smoking component of the training was replaced with adding smoke flavorings as one of the speakers was unable to attend. Food safety and meat microbiology, dry and semi dry sausages (fermenting) and the use of antimicrobials including current research on natural antimicrobials was taught.

The majority of the program was lectures by researchers from lowa State, other Universities, or companies who research various related methods. The program was very thorough and addressed the needs of people going into business or who owned a meet processing facility. A variety of questions and practical concerns were addressed through the lecture or during question and answer sessions. Research on using natural herbs to prevent microbial growth was a highlight of the program.

Upon return, Duncan has "practiced" several techniques of sausage making and has demonstrated low fat sausage for diabetes prevention participants. Pork sausage, (traditional sausage stuffed into casings) using oregano and other spices instead of cures, was sampled at the Central District PIT meeting in August.

Programs to help consumers learn food safety related to meat products and making their own products at home are planned for early 2017.

It is noted that there are a great number of Extension faculty and staff that have recently left the system, and that institutional memory is being lost. Extension professionals may wish to access success stories to reuse/recycle what has worked in the past, and to avoid those programs and processes that are deemed to be less than successful.

The Alpha Delta Chapter established this committee during the past year. At this point there has been little progress made with this task, but Worthy Chief Will Sheftall has challenged me to come up with a few ideas / directions that could be focal points for further discussion.

- The committee will need members or volunteers:
  - Good candidates for committee membership would be previous chapter officers, Life members, and recent retirees.
  - The National ESP goal of Life member engagement could be more achievable within the work of this committee.
  - Persons that have been involved in recent Extension / Land-Grant anniversary celebrations ought to be invited to participate
- Goals and highest priority objectives for the committee need to be established.
- Processes and procedures for capturing and archiving data need to be set.
  - A standard interview questionnaire might be adapted from other archiving efforts and developed to elicit success stories from veteran Extension faculty and staff.
  - The questionnaire can be used as a mail / email / website piece to elicit discussion between veterans and persons identified to conduct interviews.
  - o Data from the interview needs to be transcribed and indexing "metatags" included in the reports. Photographs with captions (metadata) need to be acquired.
  - Archived data need to be stored where they would be accessible to interested members and researchers.
     The best suggestion I have heard is to place them on a Google Drive.
  - o Permissions to share databases would be provided on request to individuals.

A historical archive of Florida Extension work was produced under the leadership of the Alpha Delta ESP Chapter in 1976. Compiled and edited by J. Francis Cooper, his book, *Dimensions in History*, describes the first 60 years of the Florida Cooperative Extension Service. (Many Florida Extension offices have a copy in their professional libraries.) Another less well known reference is *The Lamplighters – Black Farm and Home Demonstration Agents in Florida*, 1915-1965 by Barbara R. Cotton as published by USDA in Cooperation with FAMU. (It is on the Florida 4-H website)

These were useful references during the recent celebrations of the Land-Grant Sesquicentennial and the Extension Centennial. Other less well known resources were recovered through these celebrations, and it would be wise to insure that they are preserved and placed where they will remain accessible.

And for any ambitious students of Extension history out there, is there a desire to compile newer volumes that outline the more recent Extension accomplishments of our faculty and staff? *Your reactions and inputs are solicited.*



#### Minutes

#### Treasurer's Report

Lori Wiggins reviewed a summary and detailed Treasurer's Report that was sent to the board members prior to the board meeting.

#### Analyst's Report

Martha Maddox thanked the District Directors and everyone that help to encourage members to renew their dues. - Life Members: Mary Keith working on encouraging new ESP retirees to become life members. A
  meeting for retirees in the Hillsborough/Pinellas/Pasco county areas had fell through and has not
  been rescheduled at this time. The meeting would have addressed the engagement of life
  members to service on chapter committees.

#### **Committee Reports**

- Member Services/Awards: Rebecca Jordi stated that so far she has received five awards for National and will be checking on State awards during the week. Rebecca will be forwarding on the information to Lara Milligan who also co-Chairs the Member Services/Awards with her. Dr. Mary Keith volunteered to be a retiree on Member Services/Awards judging team along with Rebecca and Lara.



#### ESP Alpha Delta Chapter Reports - 30 March 2016

<u>Chapter History Committee</u>: Looking for guidance. Here are my suggestions:

 Develop an exit questionnaire that will ask persons who are leaving Extension (retiree, transfer, or leaving Service) some pertinent questions, similar to what is contained on the old Life Member application.



- History committee members can conduct interviews using the questionnaires. (A pitch to become an ESP Life member should also be made!)
- Data can be retained in multiple locations to insure that it is retained.
- Explore the possibility of compiling a follow-up volume to "Dimensions in History", [Florida Extension service history] compiled by J. Francis Cooper in 1976.

<u>Chapter Handbook</u> – no progress has been made. While this is a good idea to assist in Chapter operation continuity, it needs to be embraced by others that can devote the time to its development.

#### Southern Regional Director's Report

#### Notes from Mid-Year Board Meeting

- Accepted proposal from Alpha Rho Chapter to host *2018 ESP Conference* in Manhattan, Kansas. (Tentative dates 9/30 to 10/3)
- Membership nationally has seen a drop of 219 active members. Some of this drop is due to three chapters not submitting dues in a timely fashion. Total national membership as of 2/1 (Annual+Life) = 5118. Florida lost 11 active members since last year; total members (Annual+Life) = 220, #6 in the nation.
- Reviewed the National ESP website with an eye to making improvements for its usability, the timeliness of updating material, and linkages to social media platforms. Ad Hoc review committee will be appointed in May or June.
- On a personal note, after San Diego meeting a chance to meet up with Jennifer Pelham, former Osceola/Orange agent who is now working as a University of California "Farm Adviser" (Horticulture Agent) in San Diego.

National Scholarships Grants & Recognition Committee:



- 175 Recognition awards applications have been received from 23 chapters, including two Ruby Applications and 14 Friends of Extension applications. The only regions that failed to have a nominee in a category were the Northeast (International), and the South and West, who lacked Ruby nominees. *Florida* has put forward 5 individuals for National recognition for this year – only 5/12 categories.
- SGR Committee recommended approval of two more Angus scholarships and three nominees for National Friends of Extension. Assuming these Angus applicants are awarded by the National Board, two more Angus scholarships are available for 2016. There are also three Professional Development Grants that have not been applied for. Applications for four Redinger Administrator scholarships to attend ESP conference are now open. The Board is also expected to fund two "Special Scholarships" (\$425) to help send members of 1890 or 1994 institutions to the National ESP Conference. All applications due May 1.

ESP Winter Board Meeting March 30, 2016 President-Elect Report – Michael A. Davis, Ph.D.

- 1. Recruitment of Vice-Chairs for Committees:
  - a. There has not been much progress made on this front. However, I would like for all committee chairs to send me the name of their vice-chair, if they have one, and we can move forward from there.
- 2. EPAF Board Meeting Highlights:
  - a. Facilities:
    - i. As of now, the schedule for EPAF will be very similar to last year:
      - 1. Monday 5 Association Board Meetings (including ESP).

- 2. Exhibitors will have access to 8-foot tables and will be able to set up Monday and stay up until Friday.
- Monday evening is the Speedway Tour. Buses will begin leaving at 5pm.
  The use of personal vehicles to go to the speedway is strongly
  discouraged.

#### b. Registration:

- i. Registration should open for EPAF on April 15th.
- ii. The Dean's Office will provide funding like in the past (\$550)
- iii. Early Bird Registration is April 15 to June 1.
- iv. Regular Registration is June 2 to August 26.
- v. Late Registration is August 27 to September 9.

#### c. Tours:

i. Tours will most likely be submitted at In-Service Trainings.

#### d. Registration Costs:

i. The registration cost for each individual was set at \$400. This does not include any tours as they will be extra and based on what is presented by the association that develops the tour.

#### 3. Extension Faculty Advisory Committee Highlights:

- a. Salary Pay Plan
  - i. Brought up by agents that have been in Extension for a while and are at level IV. The previous SPP program was terminated about 6 or 7 years ago.
  - ii. This plan was used in the past for all faculty (full professors, EA IV, etc.). Very similar to the promotion packet which carries a 9% increase.
  - iii. Extension Administration is not sure where the current UF Administration stands on using a program like this at this time. There have been discussions with the IFAS Faculty Assembly and Faculty Senate, but no determination has been made at this time.
  - iv. Administration is looking for funding sources in the event that this program is brought back in some way.
  - v. It is also important to include young faculty and salary compression when talking about this issue so that there is a level playing field.
  - vi. However, at this time there is no direct funding source for an SPP.

#### b. Extension & Cuba

- This is a high priority for Dean Place since Florida has the closest proximity to Cuba. Dr. Payne has been a couple of times already and is going again during the Spring.
- ii. Also remember that UF hosts students from Earth University from all areas, not just Cuba or the Caribbean.

- iii. There is a need for information about funding opportunities to make situations work and the Dean's office is looking into these.
- iv. There should be a lot of opportunities in Cuba, especially in horticulture.

#### c. County Email vs. UF Email

i. This discussion has come about because of the UF Counsel's office. They have a hardline interpretation of what the counties should be doing that may not match up with the reality of the situation. Dr. Obreza is working with the Counsel's Office to resolve issues.

#### d. UF Emails for Program Assistants

i. Some were under the impression that Program Assistants or other staff could not have UF email addresses if they were not paid by UF. This is not the case. If you have a need for this service, call Andres at County Operations and he can help get things set up.

#### e. Updated DED Website

- Administration is moving content to the <a href="http://extadmin.ifas.ufl.edu">http://extadmin.ifas.ufl.edu</a> website. The old DED website will be phased out in the coming months.
- f. Discussion about Specialists/RECs and communication with County Offices
  - i. Agents need to make sure that communication is a 2-way street. Dr. Obreza is working on making sure that the specialists understand to keep county faculty in the loop. This is not a huge issue, but communication is always needed.
- g. Website design for County Offices
  - i. IFAS is making the transition to the T4 system. Campus and RECs are about ½ way there and now they are beginning to work with some County Offices to migrate and update websites.
  - ii. Additional templates can be found at <a href="http://branding.ifas.ufl.edu">http://branding.ifas.ufl.edu</a>.

#### h. Administrative Update

- i. Hiring 3 water RSAs now and 2 more in the near future. These will line up with the water management districts.
- ii. Dean Place is looking into an Extension Entrepreneurship Academy.
  - This would not be entrepreneurship in the traditional business sense, but would be geared toward innovation in the programmatic activity areas.
     Dean Place has had conversations with Hannah Carter and should have more information to share with a wider audience in the near future.

The Extension Faculty Advisory Committee meets four times per year to discuss current faculty issues with Dean Place and Dr. Obreza. The last meeting was held on November 23, 2015 in Gainesville. Below are issues that were discussed with relevant comments:

- 1. Two-Deep Leadership this is the policy that indicates that two or more adults should be present when youth programming is taking place. Dr. Gutter indicated that an email had recently been sent out via the 4-H RSAs to Agents and CEDs about the issue(s) with two-deep leadership. This email indicated that at 50% of states are using this method for 4-H Youth Development and other youth activities and that two-deep leadership is the standard for Florida 4-H Youth Programming. However, Dr. Gutter does understand that there may be times when this standard cannot be met. In these cases, the agent should email Chris Decubelis and Dr. Gutter as to the situation and they may grant exceptions on a case-by-case basis.
- 2. 4-H Membership Dues Chris Decubelis and Dr. Gutter are looking at documentation for membership dues for 4-H involvement that coincides with the Revenue Enhancement Initiative. They are currently looking at other states for potential ideas. They understand that more resources are needed at the state level to help county agents, and that the revenue from potential membership dues could be used to offset some of these costs. Also, there are National efforts underway to enhance 4-H from the National 4-H Council. Dr. Gutter is also looking at ways to re-engage 4-H alumni.
- 3. District-level Grant Writers It is understood that grant writing and submission is difficult for many county agents. The idea of a district-level grant writer was brought up. There are some issues with this, mainly because of funding. At this time Christy Huntley is working on grants at state level with some counties. They are also working on a possible 'clearinghouse' for available grants and a 'dashboard' for resources.
- 4. There have been some questions about use of branding on business cards, banners, etc. to include the county information or logo along with UF. There are guidelines that we use for this. Please contact Tracy Bryant if you have questions.
- 5. PDEC and Amy Harder launched the new IST system at the end of November. This revised system should help with administering and attending ISTs.
- 6. Please also refer to the Urban Extension Initiative. This was discussed during the October edition of Extension Connections with Dean Place. This is very important, but it does not overshadow the traditional partnerships that Extension has had and will continue to have with rural areas of the state.
- A question was asked on why ROAs are due in early December. The main reason for this timeline is that
  annual appraisals start in January and the DEDs need this information so that they can adequately prepare
  their part of the appraisal.

We will have another EFAC meeting early next year. If there are issues that need to be brought up to the Dean and Dr. Obreza, please let Michael Davis know so that he can put together the questions or raise the issues.

## ALPHA DELTA CHAPTER CONSITITUTION

#### Article I - Name

The name of this organization shall be the Alpha Delta Chapter, Epsilon Sigma Phi, National Extension Fraternity.

#### Article II - Purpose

#### Section A

The purpose of this association shall be exclusively charitable and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

#### Section B

This purpose includes, but is not limited to:

- 1. maintaining the standards and ideals, preserving the traditions and upholding the morale, prestige and respect of the Cooperative Extension Service; and,
- 2. developing an effective working relationship and a spirit of fraternal fellowship among the present and past employees of the Cooperative Extension Service.

#### Article III - Membership

#### Section A

#### Qualifications:

- 1. duly elected faculty, professional and administrative staff who have held full or part-time Extension appointments for a total of three or more years (the three-year requirement does not apply to ESP members in other states transferring to Florida); and,
- 2. have displayed a cooperative and helpful attitude toward fellow Extension employees, demonstrated competency in assigned fields of responsibility; and,
- 3. exhibited ability in educational techniques essential to the conduct of an effective Extension program.

#### Section B

#### Classification:

- 1. Active: Active members are those who are engaged in professional Extension work and who have met all qualifications of membership;
- 2. Life: Active Alpha Delta Chapter members may become life members upon their retirement from Extension work.

#### Section C

#### Election:

1. Membership shall be on the basis of a ninety percent (90%) favorable vote by the eligible voters who properly mark and cast their ballot.

#### Section D

Eligible Voters - All active members.

#### Section E

#### Voting:

- 1. Membership voting may be taken by mail, an alternative method or at any annual or called meeting or a combination in compliance with the requirements stated below; and,
- 2. The vote shall be reported not later than at the next annual meeting of the fraternity after the membership has been proposed.
- 3. Alternative provisions for the process of the membership to cast their votes shall be adopted at the discretion of the board of directors.

#### Section F

#### Membership Criteria

- 1. Acceptance of membership by the newly elected member shall be acknowledged in writing and accompanied by the initiation fee, prior to the date of initiation; and,
- 2. A person may withdraw from membership by notifying the Secretary in writing; and,

- 3. Any member who fails to pay annual dues shall be dropped from membership in the fraternity and shall be so notified in writing by the Secretary; and,
- 4. Any member may be expelled from the fraternity for failure to observe the obligation or for conduct unbecoming a member of the fraternity; and,
- 5. Charges may be referred in writing, signed by two members; and,
- 6. These charges shall be reviewed by the membership committee which will investigate the charges and report to the fraternity, making a recommendation and,
- 7. An accused member shall have right of personal hearing and to file evidence in regard to preferred charges; and,
- 8. Expulsion from the fraternity shall require that three-fourths of all eligible voters, as defined above, cast their ballots with a simple majority showing support of the motion to expel.
- 9. Reinstatement Any member whose membership has lapsed may be reinstated by paying regular dues and a reinstatement fee of \$10.00. Retirees are exempt from paying the reinstatement fee.

#### Article IV - Officers

The officers of this organization shall consist of a President, President-Elect, Secretary, Treasurer, Annalist, Chaplain and Immediate Past President.

#### Article V - Meetings and a Quorum

#### Section A

An annual meeting shall be at the time of the annual Extension Professional Associations of Florida, Inc. meeting.

#### Section B

Special meetings shall be held upon call of the President or upon written request of twenty percent of the members.

#### Section C

A Quorum - 15% of the paid membership shall be present to constitute a quorum at any called or special meeting of the membership.

## Article VI - Initiation Fees and Dues and Changes

#### Section A

Initiation fee - For this chapter it shall be set annually and will include state and national dues for one year.

#### Section B

State and National Dues - Shall be payable to the Secretary prior to the annual chapter meeting.

#### Section C

Changes - Made by the National Council in dues and/or fees will automatically apply to the local chapter.

ARTICLE I - Name and Mission

# The Extension Professionals' Organization

ESP is dedicated to fostering standards of excellence in the Extension System and developing the Extension profession and professional.

#### **ARTICLE I - Name and Mission**

#### Section 1. Name:

The name of this organization shall be Alpha Delta Chapter, Epsilon Sigma Phi, The National Honorary Extension Fraternity, herein referred to as ESP.

#### Section 2. Mission:

ESP is dedicated to fostering the standards of excellence in the Extension System and developing the Extension Profession and professional.

#### **ARTICLE II - Purpose**

Section 1. Purpose:

The purpose of ESP is:

- a. to serve exclusively as a charitable and educational organization within the meaning of Section 501(c)(3) of the Internal Revenue code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).
- b. to recognize excellence in the Extension community.
- c. to provide opportunity for networking, fellowship and collaborative efforts.
- d. to foster leadership development through mentoring Extension professionals in the philosophy and professional practice of Extension education.
- e. to facilitate professional development.

#### ARTICLE III - Membership

Epsilon Sigma Phi is an equal opportunity/affirmative action fraternity. Epsilon Sigma Phi is committed to the active involvement of all its members regardless of race, color, sex, age, religion, national origin, disability, or veteran status. Epsilon Sigma Phi values and seeks a diverse membership.

#### Section 1. Qualifications:

The membership of ESP shall consist of duly installed faculty, professional and administrative staff who have held full or part-time Extension appointments for a total of three or more years on June 1, and who shall have displayed a cooperative and helpful attitude toward fellow Extension employees, demonstrated competency in assigned fields of responsibility, and exhibited ability in educational techniques essential to the conduct of an effective Extension program.

#### Section 2. Classes:

There shall be three classes of membership: A) member, B) honorary, and C) life. a. MEMBER. An Extension professional (currently employed by or retired from an entity of the Cooperative Extension System) has exhibited excellence in programming and leadership. Members continue to provide leadership and excellence in Extension programming throughout their career and during retirement. b. HONORARY. May be named upon recommendation of the ESP officers and approval by two-thirds of members present and voting at the annual meeting of the Chapter. Honorary members will not pay membership dues to the Alpha Delta Chapter. A proposal of honorary membership must be accompanied by a detailed statement showing the "meritorious service" it is proposed to recognize. c. LIFE MEMBERSHIP. Members who are retired from the Cooperative Extension System, may obtain a paid-up life membership by paying an amount equal to five times the National dues at the time of the purchase of paid-up life membership or may be made as installment payments over a two year period. These members hold equal rights and privileges to those paying annual dues.

#### Section 3. Transfer of Membership:

Active members in good standing in another chapter of Epsilon Sigma Phi may transfer upon:

- a. making request to Alpha Delta Chapter.
- b. paying initiation fee and being initiated.
- c. paying annual dues.

#### Section 4. Termination of membership:

After one year of non-payment of dues, membership in ESP will be terminated. A person can be reinstated by payment of dues plus a \$10.00 reinstatement fee. Retirees are exempt from paying the reinstatement fee.

#### **ARTICLE IV - Business**

#### Section 1. Fiscal Year:

The fiscal year of Alpha Delta Chapter shall begin on the first day of October and end on September 30 of the following year.

#### Section 2. Meetings:

The annual meeting of the Alpha Delta Chapter shall be held in conjunction with the

Extension Professional Associations of Florida, Inc. meeting. Special meetings may be called by the President or upon written request of twenty percent of the members.

#### Section 3. Place of Business:

The principal place of business of the Alpha Delta Chapter, Epsilon Sigma Phi, shall be the University of Florida, Gainesville, Florida.

#### ARTICLE V - Officers, Directors, and Elections

#### Section 1. Officers:

The officers of ESP are: President, President-Elect, Secretary, Treasurer, Annalist, Chaplain, and Immediate Past President.

#### Section 2. Directors:

The directors are: one from each Extension administrative district, one from state faculty, and one from life members/retirees.

#### Section 3. Terms of Office:

The Treasurer shall be appointed annually by the President with the ratification of the membership with the option of re-appointment. All other officers are elected annually. District Directors serve a two-year term with half elected each year, according to the standing rules.

#### Section 4. Election:

The nominating committee shall present a slate of officers at the annual business meeting. ESP members present will vote, with election by majority vote.

#### Section 5. Assumption of Duties:

The officers and directors will assume their duties upon adjournment of the annual meeting at which they are elected. In the event of no annual meeting, the officers and directors will assume their duties at the conclusion of the election by mail (postal or electronically) or some alternative process approved by the Board of Directors.

#### Section 6. Filling Vacancies:

If a vacancy occurs in the President's position, the President-Elect will automatically assume the Presidency for the unexpired term and then serve another full term as President. The President-Elect's position would remain vacant until the next annual meeting.

If a Past President vacancy occurs, the previous Past President may assume the position for the unexpired term.

All other officer and director vacancies will be filled by presidential appointment, ratified by the Board of Directors.

#### **ARTICLE VI – Functions of Officers and Directors**

#### Section 1. President:

The President shall preside at all ESP meetings. The President shall appoint all chairs and committee members necessary to carry out the business of ESP.

#### Section 2. President-Elect:

The President-Elect shall assume the duties of the President in his/her absence. The President-Elect shall appoint a Co-chair of each standing committee, who will become the chair the following year.

#### Section 3. Secretary:

The Secretary shall keep accurate records of honorary members and all meetings of the Executive Board and annual business meeting.

#### Section 4. Treasurer:

The Treasurer shall keep the official record of all membership and an accurate record of all monies. He/she shall also serve as chair and liaison between the Finance Committee and the Board of Directors.

#### Section 5. Annalist:

The Annalist shall serve as Chair of the Membership Recruitment and Retention Committee. He/she shall be responsible for keeping updated biographical information on each member.

#### Section 6. Chaplain:

The Chaplain shall have official charge of all religious and memorial services.

#### Section 7. Directors:

Directors will represent the area in which they serve, attend Board meetings, and encourage membership and participation of members.

#### Section 8. Immediate Past President:

The Immediate Past President shall give counsel to the Board of Directors, chairs nominating committee.

#### **ARTICLE VII - Board Of Directors**

#### Section 1. Members:

The Board of Directors shall consist of fourteen (14) members.

- a. Officers (6) President, President-Elect, Secretary, Treasurer, Annalist, Chaplain
- b. The immediate Past President
- c. The seven (7) directors (5 Extension Districts, 1 state faculty, 1 retiree)

#### Section 2. Meetings:

The Board of Directors shall meet as follows:

a. In the fall, spring, and prior to the annual meeting.

b. Additional meetings may be called at the discretion of the President.

#### Section 3. Duties:

The duties of the Board of Directors are to set policy, transact business of ESP, and keep the membership informed.

#### Section 4. Conduct Business:

The Board of Directors may conduct business by mail (postal or electronically) or some alternative process approved by the Board of Directors when necessary. A report of each action taken shall be verified and made a part of the minutes at the next Board of Directors meeting.

#### ARTICLE VIII - Committees and their Function

#### Section 1. Standing Committees:

The President will appoint members on the basis of interest and abilities to the following committees:

- a. Nominating Chaired by Immediate Past President
- b. Membership Recruitment and Retention
- c. Public Issues
- d. Resource Development and Management
- e. Global Relations
- f. Memorial
- g. Member Services
- h. Audit
- i. Constitution &Bylaws
- j. Finance
- k. Retirees
- I. Abstracts
- m. Annual Report
- n. Webpage Management
- o. Professional Development

#### Section 2. Function:

These standing committees shall have the following duties. Additional duties may be assigned by the president. Other special committees, as needed, shall be appointed by the President.

- a. Nominating: to prepare the yearly slate of officers.
- b. Membership Recruitment and Retention: to recruit, retain and involve all ESP members and promote an effective working relationship and spirit of fraternal fellowship.
- c. Public Issues: to educate and inform ESP members about public issues and legislative matters affecting Extension programs and personnel needs.
- d. Resource Development and Management: to generate new ideas for resource development and management in order to maintain, create or enhance professional

development activities; to explore opportunities for and obtain new financial resources for professional development activities.

- e. Global Relations: to promote the Extension profession and professionalism worldwide.
- f. Memorial: to present at the annual meeting a remembrance program of those past extension professional that have passed away since the last annual meeting.
- g. Member Services: to administer and provide leadership to ESP's scholarships, loans, and awards programs.
- h. Audit: to audit the books at the end of the fiscal year.
- i. Constitution & Bylaws: to review bylaws annually submit proposed changes to the Board of Directors for review prior to submitting to the membership; to review chapter standing Rules and Policies annually submitting changes to Board of Directors for approval; to review handbook as needed.
- j. Finance: to prepare and submit proposed budget to the Board of Directors.
- k. Retirees: to recruit, retain and involve retirees and promote continued involvement in ESP.
- I. Abstracts to notify and encourage members to submit abstracts by the established due date. Responsibilities also include presiding and the facilitation of abstract presentations to adhere to the designated time allotment and to secure equipment requested by presenters for abstract presentations.
- m. Annual Report: to solicit information and reports from the officers and the committee chairmen to compile a comprehensive annual report for distribution to the entire membership.
- n. Website Management: To keep the membership up to date with all association business through routine website updates.
- o. Professional Development: To promote professional excellence, personal development and leadership development among Extension personnel. Design and implement additional professional development opportunities. Promote and foster professional improvement through collaboration with professional organizations to which Extension personnel belong. Provide leadership for mentoring activities conducted through Epsilon Sigma Phi.

#### **ARTICLE IX - Meetings**

#### Section 1. Annual Meeting:

The annual meeting of this organization shall be held during the Extension Professional Associations of Florida, Inc. conference for the purpose of furthering the objectives of the ESP, electing and installing officers, receiving reports of officers and committees, and transacting any other business that may arise. If deemed necessary, or if the scheduled annual meeting cannot be held, the President may call a special meeting to transact business with the approval of the Board of Directors. The President shall see that a notice is sent to everyone eligible for membership telling the time and place of such a meeting.

#### Section 2. Special Meetings:

The President, with the approval of the Board of Directors, may call a special session of ESP

and conduct business by mail (postal or electronically) or some alternative process approved by the Board of Directors as necessary.

#### **ARTICLE X - Quorums**

#### Section 1. Membership Quorum:

A quorum at any annual meetings shall consist of 15% of the paid membership shall be present to constitute a quorum at any called or special meeting of the membership.

#### Section 2. Board of Directors:

A quorum of the Board of Directors shall consist of 50% of the Board of Directors

#### **ARTICLE XI - Financing**

#### Section 1. Membership Year:

The membership year shall be from January 1st to December 31.

#### Section 2. Initiation Fees:

The initiation fee for ESP shall be set by the National Council. This fee shall be collected by the Alpha Delta Chapter and forwarded to the Secretary/Treasurer of the National Council, Epsilon Sigma Phi, for each member initiated. If a candidate fails to be initiated, he or she may be initiated at a subsequent meeting.

#### Section 3. Member Dues:

Dues for the coming year are payable according to the Chapter Standing Rules and Policies.

#### Section 4. Payment:

Each member shall pay annual dues to the treasurer. ESP shall pay dues to the National Council of Epsilon Sigma Phi in accordance with the amount stated in the national constitution.

#### Section 5. Life Membership Dues:

Members, retired from the Cooperative Extension Service, may obtain a paid-up life membership by paying an amount equal to five times the National dues. Life Members have the option to pay their dues in installments over a two year period.

#### ARTICLE XII – Dissolution of Organization

On the dissolution of the Association, the entire net assets remaining after payment of any and all liabilities and obligations of the Association shall be transferred to such association or associations organized exclusively for charitable, educational or scientific purposes and shall at the time qualify as exempt association or associations.

#### **ARTICLE XIII - Liability**

Epsilon Sigma Phi in no way shall be liable for the acts of individual members of the Board of Directors, nor for officers who may act beyond their authority. Officers individually or collectively

shall not be liable for Epsilon Sigma Phi, unless they have acted beyond their authority as officers.

## **ARTICLE XIV – Non-Profit Corporation**

Epsilon Sigma Phi shall conduct business like a non-profit corporation under Section 501(c)(3) of the Internal Revenue Code.

#### **ARTICLE XV – Amendments**

These Bylaws may be amended at any annual or special meeting by a two-thirds vote of the members present providing members were notified of suggested changes thirty days prior to the meeting.

# STANDING RULES AND POLICIES

Standing rules may be adopted at the annual ESP Alpha Delta Chapter membership meeting by a majority vote of the voting delegates present and voting. Standing rules may be amended or rescinded by a two-thirds vote without previous notice or a majority vote after previous notice. Standing rules may be suspended temporarily by a majority vote. Standing rules will be formally reviewed every other year (even-numbered years) by the ESP Alpha Delta Chapter Board.

## 1. Membership

Dues: annual dues are delinquent December 31 of each year.

Dues amounts: Renewing members \$60.00, new members \$70.00 (includes initiation fees), life membership (five times annual national dues) \$200.00. A former member can be reinstated by payment of dues plus \$10.00 reinstatement fee. Retirees are exempt from paying the reinstatement fee.

Dues: Cannot be refunded, but may be transferred where applicable.

## 2. Officer Nominations and Elections Process

Election of officers is held at the annual membership meeting. <u>Terms of Office</u>

- The Treasurer shall be appointed annually by the President with the ratification of the membership with the option of re-appointment. All other officers are elected annually.
- District Directors will be elected according to the following schedule:
  - Even numbered years: Northwest, Central, South, and Life Member Director.
  - Odd numbered years: Northeast, South Central, and State Specialist Director.

#### Filling Vacancies

If a vacancy occurs in the President's position, the President-Elect will automatically assume the Presidency for the unexpired term and then serve another full term as President. The President-Elect's position would remain vacant until the next annual meeting.

If a Past President vacancy occurs, the previous Past President may assume the position for the unexpired term.

All other officer vacancies will be filled by presidential appointment, ratified by the Board of Directors.

## 3. **Board Meetings**

Mid-Year Board meetings will be held at a convenient time with the President determining and arranging for the meeting place.

# 4. Conference Calls

The President will schedule conference calls as needed to carry out immediate business of the Chapter. Includes the option for Board meetings when necessary.

## 5. Bylaws

Bylaws and Standing Rules and Policies shall be reviewed annually.

## 6. Annual Budget

The voting delegates at the annual ESP Alpha Delta Chapter membership meeting shall adopt the budget for the forthcoming year.

# 7. Awards

Award Nominees must be members in good standing with Dues paid by Dec 31 to the Treasurer.

# 8. Scholarships

Applicants must be members in good standing with Dues paid by December 31 and contribute to the scholarship or High 5/10 Fund.

## 9. Memorial Service at EPAF

All effort will be made to honor deceased Faculty with Extension appointments at the

EPAF Conference following the death.

# 10. Delegates

President and President Elect or their designee will serve as delegate to all National and Regional meetings with the financial support of the chapter.

## 11. Membership Committees (Membership & Operating Details)

#### **b.** Finance Committee

Under the Bylaws, the chapter's Finance Committee is a Standing Committee chaired by the elected Treasurer, and comprised of members recruited and appointed by the President.

The Finance Committee's *annual membership* is hereby further defined to include, by office:

- The current chapter President;
- The current chapter President-elect; and
- The current Chair of the Resource Management (Foundation) Committee.

In addition, the President, with the advice and consent of the Treasurer, annually shall appoint or reappoint to the Finance Committee:

- One member-at-large not currently holding an elected office in the chapter's
  officer rotation (but could be serving currently as a District Director), who has
  served previously as Treasurer of a sister association at either the state and/or
  national level; plus
- 1-2 additional members-at-large who are interested in chapter finances and may have an interest in standing for election to the office of chapter Treasurer in a future year.

The Finance Committee's *annual operating program* is hereby further defined to include:

- Annual solicitation of Committee budget requests linked to Committee proposals for new and existing programs of value to the membership;
- Annual preparation of a draft proposed budget, to be submitted to the Board for discussion and revision at the Summer Board Meeting, prior to presentation to the general membership for adoption at the Annual Membership Meeting;
- Consultation on financial management decisions the Treasurer must make;
- At the request of the chapter Board, development of financial scenarios for chapter funds if new initiatives or programs under discussion were to be adopted and funded.

#### 1. Sharon Angela Cecile Fitz-Coy

Passed away on Saturday February 27, 2016. Sharon was born in St. Ann, Jamaica to Florine and Eric Chambers, on the 8th of November 1956. Sharon was a Senior Biological Scientist at the University of Florida. She loved to expose young students to the world of aquatic insects. She maintained that it was imperative for the youth and the wider scientific community to understand the value of the fresh water environment and its importance to the ecosystem. Her magnetic personality and infectious smile made it easy for her to interact with and meet new people. Her commitment to work was carefully balanced with devotion to her family. She is survived by her husband Norman Fitz-Coy, two sons Aric and Damek, a stepson Badyr, brother Donovan, and sisters Pamela, Christine, Carole and Maureen (Pat). Her aunts, uncles, cousins, nephews, nieces, in-laws, and life-long friends will mourn her loss.

#### 2. Isaac Chandler, Jr.

At the end of every day, as we rest from our labors, every retired agent should ask, "Have I made the best better?" Isaac Chandler, Jr. made a lasting impression on virtually everyone he came in contact. #### 3. Geoff Wallat

As Taylor County's Sea Grant marine agent for the past three years, Geoff Wallat was on hand to help anytime someone had questions or problems concerning the county's coastline, whether it was fishermen, scallopers or school children. During that time, he worked in the University of Florida IFAS Extension Office here, partnering with the local volunteer reef team, securing state grants to improve artificial reefs, leading 4-H day camps and creating educational programs for local schools. On Thursday, Nov. 19, Wallat died following a brief illness, leaving behind not only a family but a legacy of service to the people and environment of Taylor County coupled with a network of coworkers and friends.

#### 4. DeArmand LeRoy "De" Hull [\*ESP Life Member]

DeArmand LeRoy "De" Hull, 69, of Keaau, Hawaii, a retired professor of horticulture at the University of Florida and a county extension agent for horticulture in Palm Beach and Miami-Dade County, Fla., died in Life Care Center of Hilo. He was born in Lincoln, III. He is survived by spouse David Hertzberg, sisters Mary Ann Knoles and Cindy Hull, and brother Fred.

#### 5. Dr. Charles Benton (C.B.) Browning

Charles Benton (C.B.) Browning, longtime Dean of the Division of Agricultural Sciences and Natural Resources at Oklahoma State University, died at his home Tuesday in Gainesville, Florida. He was 84. Browning, who grew up in Burleson, Texas, attended college at Texas Tech before earning a master's degree in dairy science followed by a doctorate in animal nutrition from Kansas State. He began his career in education at Mississippi State, and later became chair of chair of the Dairy Science Department at the Institute of Food and Agricultural Sciences at the University of Florida and then the Dean for Resident Instruction in 1969. Browning began his career at Oklahoma State in 1979. His tenure at Oklahoma State saw a boom in funding and facilities, leading the campaign for fundraising for the Noble Research Center for Agriculture and Renewable Natural Resources. It was also during his tenure that the Animal Science Arena was completed. After his retirement he was inducted into the Oklahoma Higher Education Hall of Fame.

In an article by OSU Ag Communications at his retirement, Browning had trouble deciding his most enjoyable moments at OSU.

"It's all been fun," he said. "Oh, sure, there have been several challenges, especially in terms of budgets, but overall, it has been an enjoyable period of my life. What has not been fun is having to leave some important things undone, and not having been able to do all that people would like."

At the time, former OSU president James Halligan said, "Dr. Browning has made a difference in Oklahoma agriculture. I have been impressed with his leadership and his commitment to teaching, research, and extension programs which have benefited our students and all Oklahomans. He has been tenacious in securing support for projects in his college. He enjoys a professional reputation and respect which extends to the national level."

He is survived by his wife, Magda, his children: Susan Kreps (Gary), Charles Browning Jr. (Liz), Steven Browning (Karen), Karen Bassetti (Kevin), Heidi Dahlander (Jon), and Gary Browning (Ellen), as well as 15 grandchildren and four great-grandchildren.

#### 6. Dr. Bobby Leon Damron

Dr. Bobby Leon Damron of Gainesville passed away Tuesday, March 1, 2016 of Multiple Systems Atrophy. He was born November 6, 1941 in Ocala, FL to William Henry and Effie Eugenia Brown Damron, but was raised in Gainesville from birth. Dr. Damron graduated from Gainesville High School class of 1959. He entered the <u>University of Florida</u> in September of 1959, received his bachelor's degree in Vocational Agriculture in 1963, his Masters in December of 1964, and his Doctorate March of 1968. He joined the University of Florida faculty in Poultry Science in the spring of 1968. His appointment in IFAS was primarily for research, teaching and extension. His research was well published in scientific journals.

In 2003 he retired as full Professor Emeritus in Animal Science. He was most proud of his service as a reserve deputy sheriff in Alachua Country from January 1, 1963 to September 12, 2002. He was on the Alachua County Youth Fair and Livestock board and judged poultry. His most recent honor was being inducted into the Florida 4-H Club Hall of Fame in April of 2015. He is survived by his wife of 47 years, Vera Toole Damron, whom he met in the Florida 4-H camping program, and daughter, LenaSusanne Damron of Gainesville.

#### 7. Travis Seawright

Travis Seawright of Parrish inspired generations of Manatee County youth to pursue careers in agriculture and assisted countless farmers and ranchers during a 30-year career as Manatee County livestock agent. Mr. Seawright passed away Sunday at age 76, and is being remembered this week for the full life he lived, and for all those he

helped. "It's a huge loss for the agriculture community," said Dan West, one of Mr. Seawright's former students and manager of the Manatee County Fair. "During his tenure as agriculture teacher at Southeast High School and later as county livestock agent, he inspired so many people to go into the agriculture field, including myself." When directors of the Manatee County decided they wanted to turn the livestock show into a showcase for youth to showcase their animals, they turned to Mr. Seawright. Now, the youth livestock fair that Mr. Seawright founded is one of the largest in Florida, West said. Betty Glassburn of Duette knew Mr. Seawright for many years through her work with the fair, the 4-H Club and the extension office, and remembers his dedication to youth. "He would haul them all over the county and the state in that county van," Glassburn said. His service won him several honors, including Distinguished Service Award for Excellence in Extension Education Programs by the National Association of County Agricultural Agents; the Manatee County Employee of the Year in 1985; and Agriculturalist of the Year in 2002 for Manatee Farm-City Week. "He used to say there wasn't an inch of Manatee County he hadn't walked on, especially in the east where he worked with all the farmers and ranchers," his wife Dottie Seawright said this week.

Mr. Seawright was happiest when he was in a tractor seat, and looked forwarded to tending his citrus groves when he retired. Unfortunately, the greening epidemic killed the trees in his grove, sharing a pain felt by citrus growers all over Florida.

He was also a licensed glider pilot."He always said when he was flying in a glider with only the sound of the wind over the wings, he felt closest to God," family members said. Born in McAdams, Miss., Nov. 23, 1939, Mr. Seawright grew up in rural Mississippi on the family cotton farm. He earned a B.S. degree from Mississippi State University, in physical education and agriculture. He received his master's in agriculture extension education from the University of Florida. In 1975, he became county livestock agent with University of Florida Extension Service in Manatee Count and retired in 2005.

Survivors include his wife Dorothy, son Gene Seawright of Myakka City, daughters Doreen Lowe of Parrish, and Michelle Higdon of Clemson, S.C., seven grandchildren; two uncles, Harry Black and Wayne Black, and an aunt, Helen Smith.

#### 8. Susan Christian Camp [\*ESP Life Member]

Mrs. Susan Christian Camp, age 104, widow of Lemuel Dale Camp, died Friday, January 22, 2016 at Extendicare Health Care Center. Born Susan Robinson Christian on September 11, 1911, in the Fairview Community, Cullman County, AL, to William John Christian and Lucy Brindley Christian. Susan was one of twin girls, the other being Dixie Ryan Christian. Instilled from birth in Susan and her siblings were Christian living, the dignity of labor, honestly and conscientiously performed, and the necessity for college or university degrees. Mrs. Camp attended Berea College, Berea, Kentucky where she graduated in 1933 with a degree in Home Economics. Mrs. Camp enjoyed many years of work as an educator. Early in her career, she taught in the rural schools of Cullman County, AL and at Young Junior High School in Dothan, AL. Following this, Mrs. Camp worked as Home Economist with the Farm Security Administration, Coffee County, AL, teaching tenant farmer homemakers to produce, preserve, and store a year-round food supply as well as other skills to upgrade their standard of living. Interrupting her career in education, World War

II led Mrs. Camp into foreign assignments in Palestine (now Israel), Egypt, Germany, and Italy where she was responsible for food and other welfare needs of refugees and displaced persons of many nationalities.

Returning to the field of education, Mrs. Camp worked as Nutritionist with the Cooperative Extension Service, the College of Agriculture the Ohio State University, and likewise in the Institute of the Food and Agricultural Science of The University of Florida. She retired the latter in 1971 and moved to Dothan, AL, in 1976. Mrs. Camp was a member of the Westgate Church of Christ, the Society for Nutrition Education, the National Association of Retired Federal Employees, and professional honor societies Pi Lamboda Theta and Epsilon Sigma Phi. She spent the past 15 years at The Terrace at Grove Park. Predeceasing Mrs. Camp in recent years were a brother, Dr. Kenneth G. Christian, M.D. of Guntersville, AL, and sisters, Colfax Christian McDaniel of Arab, AL and Dixie Christian Martin of Dothan, AL. Mrs. Canty passed away peacefully on December 17, 2015 at St. Catherine Laboure Manor. She was a native of Madison County, FL, where she received her early education. Furthering her education, she earned her B.S. and Master's degrees from Florida A&M University where she met the love of her life, Major Bennie L. Canty. Mrs. Canty was a military wife, pioneer, prominent community leader and advocate. For a time she led a segregated office on Broad Street, but eventually, in 1965, the height of the Civil Rights Movement, through tenacity and sheer will, she integrated the Jacksonville-Duval County Extension Office and moved into the main Courthouse offices. Throughout her Extension career Mrs. Canty earned numerous accolades, including the Distinguished Service Award from the National Association of Extension Home Economics. Ultimately, in July 1970 Mrs. Canty became the first black person ever promoted to head an Extension Home Economics Office in the U.S., a role that would open doors and provide opportunities for future generations. She was a charter member of The Jacksonville Chapter of Links Inc. and served as chapter president for many years. She was also a dedicated member of the Beta Alpha Zeta Chapter of the Zeta Phi Beta Sorority, Inc., where she served many years as Regional Director. Mrs. Canty is predeceased by her husband; her indomitable spirit will live on in her five children, Lt. Commander Benjamin Keith Canty (Judy), Ms. Angela Gail Black, Mrs. Susan Canty Jones (Dr Kenneth W.), Howard Wayne Canty (Susan), Sumner Anthony Canty (Sheila); eleven beloved grandchildren, six treasured great-grandchildren and many loving friends.

#### 10. Harvey T. Paulk [\*ESP Life Member]

Mr. Paulk, 94, of Tallahassee died October 10, 2015 at Tallahassee Memorial Hospital.
