The Director's Corner...

We were very pleased to see several of our Extension retirees at the EPAF meeting in St. Augustine. This year's EFAF meeting was a tremendous success with over 300 faculty participating. It was exciting to distribute over 20 Faculty Enhancement Awards at the administrative breakfast on Thursday morning. Our faculty are conducting creative programs and are being recognized nationally for their excellence in Extension programming.

It has been a mixed year as far as budgets for Extension. We had a very successful legislative session including receiving funding for our workload increase in research and extension. However, as you have surely read in the newspapers, the revenue projections have plummeted since the legislature adjourned. There has been



a major call back of funding. IFAS has returned \$7.3 million to the University of Florida as our portion of the budget cut. We are also facing some challenges in county budgets as a result of property tax issue that is currently being debated in Florida. At this point, a few of the counties have received some cuts. We are very pleased at the manner in which our clientele have spoken up regarding the importance of their local Extension programs. We will keep you informed of budget issues as we proceed through the fall and the spring.

We are very pleased to announce that thanks to a gift from Alto and Pat Straughn, we will be constructing a Center for Extension Professional Development on campus. This will give us a building dedicated to professional development. Please join us in thanking Alto and Pat for making this possible.
