Retirees Rally for IFAS



The Director's Corner Greetings to all retirees. We trust that this newsletter finds you doing well. Extension continues to make great strides

due to the tremendously talented faculty that we have in our system. I wanted to mention a

few faculty that have been recently recognized. First, Dr. Martha Monroe, School of Forest Resources and Conservation received the University of Florida Scholarship of Engagement Aware for 2008. This is the second time an Extension faculty member received this award and we are proud of this prestigious recognition. Mr. Doug Gregory, Monroe County CED recently received the 3rd Annual Sustainable Fisheries Leadership Award from NOAA. Dr. Laurie Treholm, Dept. of Environmental Horticulture received the Turf Educator Award of Excellence from Turfgrass Producers International.

As you are aware, the past four months have been challenging from a budget perspective. We have faced internal issues at UF as well as the challenges with the legislature. I am so grateful to you and our many clientele who have spoken so clearly about the importance of IFAS and the land grant mission of UF. We will never be able to individually thank everyone that voiced their concern.

Relative to the budget, there is both good news and bad news. The good news is that IFAS was not disproportionately cut. We received the same 6% cut that every other part of campus received. The bad news is that the 6% cut was \$9.5 million. This cut forced the elimination of both faculty and staff positions. Some staff members will be terminated, and this is painful. We have maintained the IFAS footprint throughout the state including all county offices and research and education centers. There will be some reorganization of departments as a result of the cuts. There is a major overhaul of EDIS underway. Recent improvements include increased

searching capabilities. We now have over 6000 EDIS publications.

Finally, I hope to see many of you at the Extension Professional Associations of Florida meeting in Orlando. Join us for the 4-H Golf Tournament on Monday if you can.




President's Report...


