Greetings to all retirees! As you may all know by now, Dr. Larry Arrington was appointed interim senior vice president for UF/IFAS

by President Machen at the beginning of this year. Larry has asked me to step in as interim dean for extension for the next year until the senior vice president's position is filled. It will be difficult to step into Larry's shoes, but I am willing to assist in any way I can. In our newly appointed positions, Larry and I face a very challenging year as we look at some potential revenue shortfalls.

President Machen has asked the campus to prepare for a ten percent budget cut. This 10% reduction puts IFAS in a very difficult position. It was difficult enough with last year's cuts and yet, due to the economic decline, President Machen is requesting for a plan to cut 10% more. The ten percent reduction for IFAS comes to \$16.4 million. While we are preparing for a ten percent reduction, we are hoping that our actual


reduction may be less. At this point it is only a plan as we will not know the actual budget situation until after the regular legislative session adjourns. We continue to need your support during these difficult times.

On a more positive note, I want to let you know that there will be no pull backs on this year's budget; therefore, we are still planning for our 2009 Extension Symposium to be held May6-8th at the Hilton in Gainesville. I am very committed to faculty development opportunities and this is an important means for our faculty to gather as a family to learn from each other. At the present time we are in the process of putting together the short workshop descriptions that will be part of the program booklet. We will be officially announcing registration very soon.

Finally, I wanted to let you know that Dr. Tom Obreza, Professor, in the Soil and Science Department has agreed to help me out on parttime bases as Interim Associate Dean. He will be an excellent addition to our administrative team. Regards, Millie

Another Budget Cut?....

Despite the recent emergency budget cutting session to fill a \$2 billion-plus budget gap,

legislators may need to fill another hole within the next few months.

Senate budget chairman J.D. Alexander has said tax revenues for December and January were expected to be **\$224 million below predictions**.

This huge drop-off will have to be addressed by lawmakers before June 30, the end of the fiscal year. However, with only a few months left in this budget cycle, there is little spending left to be reduced. That leaves yet another round of borrowing from depleted savings accounts and trust funds as the likely fix.

Gov. Charlie Crist may have made matters worse last week by reversing more than \$360 million of the budget cuts that lawmakers approved. The governor's promise to revive those spending cuts may be short-lived.

Alexander said the December and January revenue drops would create an additional \$1.5 billion budget hole to fill for the next fiscal year on top of the expected \$2.5 billion shortfall.

To put it in some perspective, consider that the state's total budget in July 2006 was more than \$71 billion. With two years of budget cuts expected to continue well into next year, the state's budget could drop to \$61 billion or lower for the next fiscal year – about a ten percent cut in spending over three years.

To make matters worse - Alexander said the counties' ad valorem property tax collections may drop by \$1 billion statewide due to the plummeting real estate values. And the pricetag for the voter-approved class size limits is coming due with the state Department of Education requesting an additional \$1 billion for new teachers and construction to meet the constitutional mandate.

May 1, 2009 is the tentative deadline to go to press with a new book I am writing (my first). It is genealogy related on my mother's side of the family, DeVane, including family lineages and stories. My "small project" has grown immensely to include any southern DeVanes that I can link back to our first immigrant ancestor who came here from France in 1720. Tentative title is "*Our Southern DeVanes: Family Trees and Stories, 1700 - 2008.*" If you know any DeVanes in your community, please encourage them to check with me to see if they are in my database and future book. The DeVanes descend from a line of very patriotic, proud, hard-working and fun-loving people, which is what I hope to relate to future generations through this book. My DeVane ancestors have fought in every war the U.S. has engaged in, beginning with the Revolutionary War. My grandfather, Aaron DeVane, played on the first or second football team for University of Florida, before moving to Gainesville when they were still based at Lake City. His also taught me to understand football. His sister, Connie DeVane, was a Home Demonstration Agent for a short while in Citrus and DeSoto counties. She worked with the women and youth teaching them through Poultry Clubs. She learned so much from the UF specialists that she decided to demonstrate what she had been teaching, so she bought 40 acres in Manatee County where she bred poultry, raised chickens, citrus and cattle, and had a very successful small farm for many years.

One of the recent highlights was a large DeVane family reunion last October in the Wilmington, NC area. I had my laptop set up with the DeVane database running. In attendance were three African-Americans who were trying to confirm their DeVane connections. The early DeVanes were large landowners with plantations and slaves. As in several cases that have come to light over the years, the plantation owner had impregnated one or more of the female slaves. The young man attending knew his DeVane background and had it well-documented. He helped me work with two sisters in finding the final connection to link them to the DeVanes. This was a very positive experience for all in my family who attended, so together with my African-American cousins we are writing one chapter in the book to be "Bridging the Racial Divide."
