Cloverbud Explorers: Enhancing Cloverbud Engagement Countywide

Section 1 - Current Involvement and Leadership in FAE4-HA

As an active member of FAE4-HA, I currently serve as President-Elect (2024-2025) and have previously held multiple leadership roles, including 1st Vice President (2023-2024), 2nd Vice President (2022-2023), and District 9 Director (2021-2023). Additionally, I serve on the Programs Committee and Member Recognition Committee, supporting member engagement, professional development, and statewide programming initiatives. I have contributed as a State Communicator Awards Judge (2019-2024), State Awards Judge (2024), and Abstract & Poster Reviewer (2018-2022, 2024). My scholarly contributions include 92 multimedia presentations at local, state, and national levels, 29 refereed abstracts, 13 national conference presentations, and 11 state presentations. I have also coauthored 1 refereed and 10 non-refereed publications, reinforcing my commitment to advancing best practices in 4-H youth development. Beyond leadership and scholarship, I actively serve on the 4-H Volunteer Action Team, 4-H School Enrichment Action Team (2021-2025), and the Opportunity for All Workforce Development Committee (2020-2024), where I facilitated a book club in 2022. Additionally, I provide leadership to the 4-H Area West Horse Show Committee as a Chair/Co-Chair (2024/2023).

Section 2: Outline your plans and include a timeline. Include your plans to enhance the program as well as how you plan to share what you accomplished with your-peers.

Polk County 4-H has seen continuous growth in Cloverbud enrollment, increasing from 79 participants in 2022–2023, to 93 in 2023–2024, and 139 in 2024–2025. Feedback from volunteers, families, and program evaluations highlighted the need for more structured, countywide learning experiences beyond clubs, as well as curriculum support to enhance Cloverbud programming. In response, the Cooking with Cloverbuds program, a four-part cooking series led by the Family and Consumer Science agent was introduced during the 2023–2024 4-H year. To further support club leaders and families, four Cloverbud curriculums (Exploring 4-H, All About Pets, All About Insects, and Marshmallow Rockets) were provided at no cost, enriching learning opportunities within 4-H clubs. The Polk County 4-H Cloverbud Fair also offers a non-competitive environment for Cloverbuds to showcase their project work, fostering confidence and self-esteem. Building on these efforts, we aim to expand programming by adding monthly educational workshops, enhanced volunteer training, and curriculum support to create a more structured and engaging Cloverbud experience.

Cloverbud Explorers Implementation Timeline -Volunteer Training & Curriculum Support

The countywide Cloverbud program called the Cloverbud Explorers will launch in September 2025 and run through April, culminating in the 4-H Cloverbud Fair.

- Dec 2024 Jan 2025: Recruit Cloverbud Program Committee volunteers, review, and order Big Book of 4-H Cloverbud Activities.
- Feb Mar 2025: Establish a committee, define roles, plan activities using *The Big Book of 4-H Cloverbud Activities* and recruit skill-based adult and teen volunteers for monthly workshops.

- Apr Jun 2025: Finalize workshop activities, develop Grab-and-Go Activity Boxes, and identify community spaces to hold monthly workshops.
- Jul Aug 2025: Train volunteers on curriculum and workshop facilitation, assign roles, and promote the program to families.
- Sept 2025: Launch Cloverbud Explorers with an introductory session.
- May 2026: Evaluate the new model, volunteer training and usability of the boxes.

Program outcomes and successes will be shared through workshops and poster sessions at state and national conferences, 4-H monthly connections, in-service training, and resource-sharing efforts, serving as a scalable model for other counties looking to expand or support Cloverbud programming.

With increasing Cloverbud enrollment in Polk County 4-H, this expansion ensures a consistent, high-quality educational experience at both the county and club levels. While the Polk County 4-H Foundation provides up to \$300 in funding for the Cloverbud Fair, this award will fully equip six Grab-and-Go Activity Boxes, which serve as structured curriculum for volunteers, strengthen their confidence in leading activities, and establish a sustainable, replicable Cloverbud program model.
