## Narrative:

- 1. Dallas became my mentor in 2022. She came to my county to meet with me and communicated through video chat, email, and text over the last three years. She was critical in helping me better understand my job and the mission of UF/IFAS Extension. She walked me through her program and ROA/POW to provide more understanding of the work I would need to do with my volunteers and youth.   - Some of Dallas' most successful programs include the Hope Forest Garden, her volunteer program, and her school enrichment program. She also has a strong volunteer program with over 80 annual volunteers that supports 36 community clubs and six in-school clubs, reaching over 1,700 youth members. Her school enrichment programs reached over 6,500 youth this year.
